## Terms and Conditions:-

- The Bidders shall deposit bid security for Rs.10,000/-. The bid security shall be pledged in the name
  of Registrar General, High Court of Uttarakhand, Nainital in the form of demand draft or fixed deposit
  receipt or Bankers cheque or Bank guarantee to the satisfaction of undersigned safeguarding the
  interest of the High Court in all respects.
- Bid securities of the unsuccessful bidders shall be returned to them at the earliest after expiry of the final bid validity but not later than 30 days after the award of the contract by the High Court.
- 3. To ensure due performance of the contract, successful bidder will be required to furnish performance security which shall be 5% of the value of the contract safeguarding interest of High Court in all respect. Performance security may be furnished in the form of account payee demand draft, fixed deposit receipt from Commercial bank, Bank Guarantee in an acceptable form safeguarding High Court's interest in all respects.
- 4. Performance security should remain valid for a period of 60 days beyond the date of completion of all contractual obligations of the suppliers/bidders including warranty obligations.
- 5. Bid security shall be refunded to the successful bidder on receipt of performance security.
- 6. The firm shall have to supply the requisite items within a period of 21 days from the date of order. In case of failure, the Registrar General shall have right to take appropriate action including forfeiture of security.

- 8. If any item supplied by the firm is found not upto the mark, the items will not be accepted and supplier shall be liable to pay 5% of cost of items as damages and it may be adjusted from the security amount or shall be recovered.
