Section - 1: Introduction

The High Court of Uttarakhand has been implementing the e-Courts Project in all District & Subordinate Courts (financed by GOI). The scope of the e-tender is to equip all the District & Subordinate Courts with necessary Hardware for Court Complexes in the State of Uttarakhand for its computerization. This e-tender caters to the supply, connect, test, installation, test and maintenance of Hardware systems and related sub-systems required for the Project. Sealed e-tenders for Hardware, valid for a period of given in e-tender, are invited to supply, install and operationalize the items as given in the "Annexure: D (i), D(ii) & D(iii)".

The Hardware shall be procured in a transparent manner through a competitive bidding process following the procedures stipulated in the Uttarakhand procurement rules. Selected bidder(s) would be required to provide warranty Support and Repairing services and replacements to the supplied Hardware through Service Support Centres / Resident Engineers in all the 13 Districts across Uttarakhand.

The selected bidder(s) shall be responsible for supplying, testing, quality inspection, installation, delivery of the Hardware and providing warranty & support services for the requisite quantity of hardware as per the scope of work during the entire project / contract period of the Agreement. The bidder(s) shall also be responsible for loading and installing any content like Software etc., provided by High Court of Uttarakhand for the hardware before offering the same for pre-delivery inspection / delivery.

Section – 2: Eligibility Criteria

The Bids must be complete in all aspects and should cover entire scope of work as stipulated in the tender document. This invitation to tender is open to all the bidder(s), who qualify the eligibility criteria as given below:

1.	The bidder(s) should be an OEM/Company/Distributor having experience of minimum 5 years in India .

Note: if quoting bid for 1 item, bidder(s) must submit the turnover of Rs. 1 crore and if quoting bid for 2 items, bidder(s) must submit the turnover of Rs. 2 crore (one crore for each item) and if quoting bid for 3 items, bidders must submit the turnover of Rs. 3 crore (one crore for each item) and so on.
4.	The bidder(s)/OEM should have certification from an accredited and internationally reputed firms for ISO 9001:2008 (equivalent or higher)
5.	Preferential: The bidder(s) must have implemented & operationalized 3 similar projects of value 3 crores in total (cumulative) as on 31.03.2018. The completed projects should clearly demonstrate work inclusion like supply, installation, setup-configuration, support in Central Govt./ State Govt./ High Courts/ PSU/ Autonomous bodies Statuary bodies of Govt. of India.
6.	The Bidder should have at least one office in Uttarakhand and preferably support centers/logistics for the entire state or the bidder must provide undertaking to open the same within 30 days after award of contract. The bidder must mention that if he fails to open the office in given time then his work order shall be deemed cancelled.
7.	The OEM/ Distributor should be ready to supply in one lot in specific time.
8.	Bidder should not be under a declaration of ineligibility for corrupt or fraudulent practices issued by Government of India or by Government of any other State in

	India or by Government of Uttarakhand or by any High Court or any of the PSU in					
	India at the time of bidding.					
9.	Bidder should not have violated/infringed any Indian or foreign trademark, patent, registered design or other intellectual property rights any time anywhere in India.

Section – 3: Scope of Work

The selected bidder(s) is expected to carry out all the activities covering supply including delivery, installation and configuration setup, testing and quality inspection etc. in coordination with High Court of Uttarakhand.

Detailed scope of work for the project is as given below:

Supply and Delivery of Items

Supply all the required quantities of item(s) to the locations as mentioned in the 'Annexure-D(i), D(ii) & D(iii)' having the Specifications as provided in 'Annexure-C'.

Conduct 100% quality inspection and testing to ensure that each and every item complies to the specifications given in Annexure-C titled "Specifications for Hardware Items for Courts" and ensure that there should not be any physical damage(s) and shall contain all the required items accessories before declaring the all items as "Ready for delivery".

Scope of Supply

- a) Subject to the provisions in the bidding document and contract, the goods and related services to be supplied, shall be as specified in the bidding document.
- b) Supply, Installation, Configuration, Operation, On-site support of the listed hardware; Resident Support Engineer Manpower Supply. Operation of Call/ Service Center for Grievance Redressal and support at all listed District Court sites in Uttarakhand for smooth operations with 5 Years On-site Warranty and Operational support from the date of Supply of listed Hardware as per the e-tender.
- c) The bidder(s) shall not quote and supply any hardware/ software that is likely to be declared as End of Sale/ End of Life in coming 5 years and End of Service/ Support in coming 5 years from the date of tender submission. If any of the hardware/ software is found to be declared as End of Sale/ Service/ Support in the period mentioned above, then the bidder(s) shall replace all such hardware/ software with the latest ones having equivalent or higher specifications without any financial obligation to the purchaser.
- d) The tender proposal shall be inclusive of a five (5) years on-site warranty support with Level 1 support from bidder(s) and Level 2 support from OEM for all the hardware items including software applicable (if any) from the date of Delivery of materials adhering the e-tender SLA (Service Level Agreement) clauses. The bidder(s) shall obtain the successful installation and commissioning report from concerned authority at each location. The bidder(s) shall maintain systems and peripherals supplied and installed

under this e-tender in accordance with the provisions laid down in the clauses below during the warranty period.

Delivery Schedule:

The Bidder shall ensure that all the required quantities of the ordered items are supplied and delivered to the desired locations as per the schedule given by the High Court of Uttarakhand at the time of delivery.

Delivery Process

- a) All aspects of safe delivery shall be the exclusive responsibility of the Vendor. At the destination site, the original packing shall be opened only in the presence of concerned Nodal Officer(s) of respective site/location and Vendor's representative. The intact position of the seal shall form the basis for receipt of items in good condition (not tampered).
- **b)** The Vendor must apply to the respective authority for issue of road permit/way-bill in time.
- c) Delay on account of getting relevant permits shall not make Vendors' eligible for waiver of penalties.
- **d)** Delivery Challans needs to be signed and stamped on completion of delivery of items. In case any discrepancy with regard to sign, stamp or date etc on above Delivery Challans, a mail from concerned Nodal Officer may be treated as Delivery Challan.
- e) The Vendor should install all the items at specified site without any additional charge.
- f) Though the High Court of Uttarakhand shall provide all the necessary documents for ensuring smooth delivery of goods at the respective destinations, it is the responsibility of the Vendor to deliver the goods in time.
- g) Subject to the conditions of the contract, the delivery of the goods and completion of the related services shall be in accordance with the delivery and completion schedule as specified in the bidding document or mutually agreed terms and conditions. The details of supply/ shipping and other documents to be furnished by the successful/ selected bidder(s) are specified in the bidding document and/ or contract.
- h) The contract for the supply can be repudiated at any time by the High Court of Uttarakhand, if the supplies are not made to his satisfaction after giving an opportunity to the bidder(s) of being heard and recording the reasons for repudiation.

- i) The supplier/ selected bidder(s) shall arrange to supply the ordered items as per specifications within the specified delivery/completion period at various sites/locations mentioned in the bidding document and/or contract.
- **j)** Shifting the place of delivery destination:

High Court of Uttarakhand shall be free to shift the place of delivery within the same District. The successful/ selected bidder(s) shall provide all assistance including transportation in shifting of the delivered Items.

Installation Process

- a) During installation at site, if any item is found defective or broken, it shall be replaced with new one by the Vendor at its own cost and risk within 15 days from the date on which the Vendor has been informed of such damage.
- **b)** Consolidated Installation report, based on the successful installations of the individual item, duly signed by the Nodal Officer of the concerned site/location identified by District Judge should be submitted to the High Court of Uttarakhand along with the bills.
- c) It may be noted that only the items technically tested/accepted as per Purchase Order shall be installed as per the schedule mentioned Below –

Applicable Law

- a) The Agency shall be governed by the Laws and Procedures established by Government of India/State Government, within the framework of applicable legislations and enactment made from time to time concerning such commercial dealings/processing.
- b) All disputes in this connection shall be settled in Nainital Jurisdiction only.
- c) The Registrar General, High Court of Uttarakhand also reserves the right to modify/relax any of the terms & conditions of the e-tender.
- d) In case the selected bidder(s) fails to complete/comply the order within given time frame, then necessary action shall be taken against the said firm by forfeiting EMD/PG followed by blacklisting of the said firm or as applicable in such matters. In such case suitable penalty may be imposed on the said firm. Decision of Registrar General, High Court of Uttarakhand shall be final and binding in such matters.

Help Desk Setup:

The selected Bidder as part of provisioning support for all the users at each court location site, shall setup centralized help desk and coordinate with the respective OEM of the Hardware deployed at District & Subordinate Courts in Uttarakhand. The selected Bidder shall undertake the following:

- **a)** A Helpdesk shall be set-up for facilitating and monitoring of warranty services provided by the successful bidder(s) through the service support centers / resident engineers.
- b) Provide Help Desk services to track and route requests for service and to assist all the users in answering questions and resolving problems related to the IT Infrastructure installed as per Annexure'D(i), D(ii) & D(iii)'.
- c) The Help Desk setup shall be the central collection point for contact and control of the hardware problem, hardware defects/change and service/incident management processes.

- d) Shall provide a first level of support for the supplied hardware related issues and technical support at the delivered court location/sites across the Uttarakhand State where the hardware shall be installed.
- **e)** Shall provide integrated customer support by establishing 9 hrs X 6 days Help Desk facility for reporting issues/ problems with the supplied hardware by the bidder(s).
- f) Service desk is an application that facilitates the end-to-end service support. The proposed system should include all the supplied hardware by the bidder(s).
- **g)** The bidder(s) shall provide a standard operating procedure for the Help Desk, the document shall contain the contact numbers, email ids of the co-coordinators, call center staff, escalation matrix and call log-in facility.
- h) On the receipt of the problem resolution/defect call, the Service Center/ Resident Engineer shall expeditiously analyze the cause and if the defect reported cannot be handled by him/service center, this should be reported to the company support center. The bidder(s) is responsible for replacing the defective goods or parts thereof with brand new genuine/ original ones having similar or higher specifications, at no cost to the purchaser and user in 2-4 working day.
- i) In case the defect is not rectified by the Service Centre Representative/Resident Engineer and/or all the items/parts are retained by the Service Support Center / Resident Engineer, the problem shall be logged at the Help-desk and a ticket number shall be generated by the Help-desk. While generating the ticket, the Help-desk shall also capture contact information of the user like his /her Mobile Number / email ID to intimate the users after resolving the incident post repair or replacement (if applicable) within the given time.
- j) The Bidder shall: Register the defects reported at any of the service support center / Resident Engineer in system, generate ticket number and take steps to resolve the complaint and inform the user/complainant and / or take feedback from the user / complainant
- **k)** The Bidder shall: Provide necessary telephonic support to all the users facing issues related to non-timely support/ service from the Bidder's Service support centers/ Resident Engineers deployed by the Bidder

Section – 4: Instructions to Bidders

Cost of Bidding

- The Bidder shall bear all the costs associated with the preparation and submission of the Tender. High Court of Uttarakhand shall in no case be responsible for those costs, regardless of the conduct or outcome of the bidding process.
- The Bidder shall have to remit Non-refundable Tender Processing Fees of Rs. 5,000/-in the separate cover within the main sealed cover containing EMD, on or before the date & hour of submission of the bids at High Court of Uttarakhand office. Tender processing fees must be in the form of Demand Draft in the favor of "Registrar General, High Court of Uttarakhand" payable at Nainital along with the covering letter. Please affix the stamp of your company on the overleaf of demand draft.

Bidding Documents

Bidder can download the tender document from https://www.uktenders.gov.in/ and upload the same on https://www.uktenders.gov.in/ on or before due date of the Tender. Bidder is expected to examine all instructions, forms, terms, and specifications in the bidding documents. Failure to furnish all information required by the bidding documents or tender not substantially responsive to the bidding documents in all respect may result in the rejection of the Tender.

Amendment of Bidding Documents

- At any time prior to the deadline for submission of bids, High Court of Uttarakhand, for any reason, whether at its own initiative or in response to the clarifications requested by prospective bidder(s) may modify the bidding documents by amendment and upload accordingly.
- All prospective bidder(s) are requested to browse our website and any amendments / corrigendum / modification shall be notified on e-tender website only and such modification shall be binding on them. Bidders are also requested to browse the e-tender website i.e. https://www.uktenders.gov.in/ for further amendments if any.
- In continuation of the amendment of the bidding documents, High Court of Uttarakhand, at its discretion, may extend the deadline for the submission of bids.

Language of Tender

The Tender prepared by the Bidder, as well as all correspondence and documents relating to the Tender exchanged by the Bidder and High Court of Uttarakhand shall be in English.

Sections Comprising the Bids

5.1 Tender Security Section:

Tender Processing Fees & EMD Details: The tender processing fee (non-refundable) & EMD (refundable) to be furnished to the High Court of Uttarakhand office in a separate envelop on or before date & hour of submission of etender.

5.2 Eligibility & Technical Section:

Two bid system - Two covers system/two envelops system/two bid system shall be followed for the tender:

- **Technical bid** –Qualification, Technical Proposal, Fee Details, EMD, essential supported certificates/ documents etc are to be submitted by the bidder(s).(**Annexure** 'A' & 'C')
- **Financial bid** –Financial Proposal in the given format, termed as Financial Tender. (**Annexure 'B'**). Bidder may quote rates of all the items or any particular item.

If, bidder is willing to supply only one item then bidder should quote '0' (zero in numeric) in the price of rest of the each item. High Court of Uttarakhand reserves its right to give work order to more than one firms for different items as per eligibility/feasibility and lowest price, for which no claim whatsoever can be raised by the bidder(s).

Bidder should also submit the original copy of all the certificates at High Court of Uttarakhand Office before due date of etender.

Tender Forms

- Wherever a specific form is prescribed in the Tender document, the Bidder shall use the
 form to provide relevant information. If the form does not provide space for any required
 information, space at the end of the form or additional sheets shall be used to convey
 the said information. Failing to submit the information in the prescribed format, the
 tender is liable for rejection.
- High Court of Uttarakhand shall not be bound by any printed conditions or provisions in the Bidder's Tender Forms.

Fraudulent & Corrupt Practice

Fraudulent practice means a misrepresentation of facts in order to influence a
procurement process or the execution of a work order and includes collusive practice
among Bidders (prior to or after Tender submission) designed to establish Tender prices
at artificial non-competitive levels and to deprive the High Court of Uttarakhand of the
benefits of free and open competition.

- "Corrupt Practice" means the offering, giving, receiving or soliciting of anything of value, pressurizing to influence the action of a public official in the process of work order execution.
- High Court of Uttarakhand shall reject a proposal for award and may forfeit the EMD and/or Performance Guarantee if it determines that the bidder(s) recommended for award is engaged in corrupt or fraudulent practices in competing for, or in executing, contract(s).
- Any effort by a bidder(s) or bidder's agent / consultant or representative howsoever described to influence the High Court of Uttarakhand in any way concerning scrutiny / consideration / evaluation / comparison of the tender or decision concerning award of contract shall entail rejection of the tender.

Lack of Information to Bidder

The Bidder shall be deemed to have carefully examined all the contract documents to his entire satisfaction. Any lack of information shall not in any way relieve the Bidder of his responsibility to fulfill his obligation under the Contract.

Contract Obligations

If, after the award of the contract, the bidder(s) does not sign the Agreement or fails to furnish the Performance Bank Guarantee (PBG) along with the inception report and working schedule as per the tender requirements & if the operation is not started within 15 working days after submission of PBG as mentioned in the tender, High Court of Uttarakhand reserves the right to cancel the contract any time and apply all remedies available under the terms and conditions of this contract.

Tender Price

- The priced tender should indicate the prices in the format/ price schedule only.
- Bidder may quote rates of all items or any particular item. If, bidder(s) is willing to supply
 only one item then bidder(s) should quote '0' (zero in numeric) in the price of rest of the
 each item. High court reserves its right to give work order to more than one firm for
 different items as per eligibility/feasibility and lowest price, for which no claim whatsoever
 can be raised by the bidder(s).
- Price shall be inclusive of all freight, forwarding, transit insurance and installation charges.

- The price tender should be separately shown with details of all applicable taxes.
 Successful Bidder shall have to supply/provide goods with an Invoice from a place located within State of Uttarakhand.
- The prices should include 5 Years warranty for all proposed hardware and 5 Years warranty/support for proposed software's which is supplied.
- The Bidders should quote prices strictly as per the price composition stated above, failing to which the offers are likely to be rejected.
- If the Hardware/Software is extended/upgraded any time in between, the prices for the
 additional components/software's should be same during the warranty period and for
 upgrades beyond rates should be separately mentioned with a validity for the next AMC
 term effective date of purchase order (PO) for the same.
- The Bidder should provide the rate card for the hardware components including its hardware and software setup in case of extension/expansion/upgrades at a later date, as and when requested.

Licensing Requirements

- All OS/ System software/ Other Applicable Software, licenses, etc. have to be procured
 in the name of the High Court of Uttarakhand. The system software/ other applicable
 software licenses mentioned in the Bill of Materials or provided along with, shall be
 genuine, perpetual, of full use and should provide upgrades, patches, fixes, security
 patches and updates directly from the OEM.
- Bidder (SI/OEM/Distributer/Partner) shall provide a comprehensive warranty that covers
 all components after the issuance of the final acceptance by the department. The
 warranty should cover all materials, licenses, services, and support for all the related
 software's, patches upgrades for the period of entire project duration. SI shall administer
 warranties with serial number and warranty period.
- Bidder (SI/OEM/Distributer/Partner) shall transfer all the warranties to the High Court of Uttarakhand at no additional charge at the time of termination of the project. All warranty documentation (without expiry) shall be delivered to the department.
- Any mandatory/optional OS and Softwares installed should be licensed under Open/Perpetual Licenses for at least 5 Years.
- Any mandatory/optional Open Source OS and Softwares installed should be licensed under subscription based/Open/Perpetual Licensing conditions for at least 5 Years.

Road Permit

In case of delivery of hardware to the areas where Road Permit is required for transportation of goods, it shall the responsibility of the Bidders to provide the same, making all the arrangements required in advance without any extra cost to the High Court of Uttarakhand. However, High Court of Uttarakhand shall provide a letter, if required, to the Bidders for carrying out the task.

Tender Currency

The prices should be quoted in Indian Rupees. Payment for the supply of equipment as specified in the agreement shall be made in Indian Rupees only. The tender validity would be for a duration of **180 days** from the last date of submission of tender.

Tender Security / Earnest Money Deposit (EMD)

The bidder(s) shall have to submit Non-refundable Tender Processing Fees of Rs. 5,000/- & Earnest Money Deposit (E.M.D.) of Rs. 5,00,000/- (Refundable) on or before date & hours of submission of tender in a sealed cover at High Court of Uttarakhand office with the heading "etender for Supply and Installation of Hardware under e-Court (Phase-II) Project"

- Tender processing fees must be in the form of Demand Draft in the name of "High Court of Uttarakhand" payable at Nainital along with the covering letter.
- Tender Security / EMD as mentioned above, shall be submitted in favour of Registrar General, High Court of Uttarakhand, in the form of Demand Draft <u>OR</u> in the form of an unconditional Bank Guarantee (which should be valid for minimum 6 months from the last date of tender submission) of any Nationalized Bank or Commercial Banks or Co-Operative Banks and Rural Banks operating in India

Note: Failing to submit physical covers of EMD and tender processing fees as mentioned above on or before given time may lead to the rejection of the tender.

- In case of non-receipt of tender processing fees & EMD as mentioned above, the tender shall be rejected by High Court of Uttarakhand as non-responsive.
- E.M.D. of Unsuccessful bidder(s) shall be returned as promptly as possible after the expiration of the period of tender validity OR upon the successful Bidder signing the Contract, and furnishing the **Performance Bank Guarantee** @ 5% of the total order value as prescribed by High Court of Uttarakhand, whichever is earlier.

- The successful Bidder's E.M.D. shall be returned upon successful completion of the work.
- The EMD may be forfeited at the discretion of High Court of Uttarakhand, on account of one or more of the following reasons:
 - a) If a Bidder withdraws its tender during the period of Tender validity.
 - b) If Bidder does not respond to requests for clarification of their Tender
 - c) If Bidder fails to co-operate in the Tender evaluation process, and
 - **d)** In case of a successful Bidder, the said Bidder fails:
 - i. To sign the Agreement / Contract in time
 - ii. To furnish Performance Bank Guarantee
 - **iii.** If the bidder(s) is found to be involved in fraudulent practices.

Period of Validity of Bids

- Bids shall remain valid for 180 days after the last date of tender submission prescribed by the High Court of Uttarakhand. A Tender valid for a shorter period shall be rejected as non-responsive. Tender Due Date

- Tender must be uploaded by bidder(s) not later than the date specified in the e-tender.
- The High Court of Uttarakhand may, as its discretion, extend the tender due date, in that

 previously subject to the tender due date, shall thereafter be subject to the new tender
 due date as extended.

Modification and Withdrawal of Tender

Modification and withdrawal of bids shall be as per provisions given in Uttarakhand
Procurement Rules. The bidder will not be allowed to withdraw or modify the bid in the
interval between the deadline for submission of bids and the expiration of the period of
tender validity, specified by the bidder. Withdrawal of a Tender during this interval may
result forfeiture of EMD/PBG followed by suitable action as deemed fit by High Court of
Uttarakhand.

Opening of Bids

- Bids shall be opened in the presence of Bidder's representatives, who are willing to attend.
- The Bidder's names, tender modifications or withdrawals, discounts and the presence or absence of relevant Tender security and such other details as the High Court of Uttarakhand at its discretion, may consider appropriate, shall be announced at the opening.
- Immediately after the closing time, the officer authorized by the High Court of Uttarakhand shall open the Un-Priced Bids and list them for further evaluation.

Evaluation of Bids

- Only the proposals received upto due date and time at the designated place shall be considered for evaluation. To facilitate evaluation, Office of Registrar General, High Court of Uttarakhand may, at its sole discretion, seek clarification in writing from any bidder(s).
- Bidder may quote rates of all items or any particular item. If, bidder(s) is willing to supply
 only one item then bidder(s) should quote '0' (zero in numeric) in the price of rest items.
 High Court of Uttarakhand reserves its right to give work order to more than one firms for

- different items as per eligibility/feasibility and lowest price, for which no claim whatsoever can be raised by the bidder(s).
- Tender evaluation shall be done on the basis of eligibility criteria, technical specifications, feasibility, suitability and price of individual item (not on the basis of total cost of all the items). High Court of Uttarakhand reserves its right to give work order to more than one firms for different items as per eligibility/feasibility/suitability and lowest price, for which no claim whatsoever can be raised by the bidder(s).

Contacting High Court of Uttarakhand

- Bidder shall not approach High Court of Uttarakhand officers after office hours and/ or outside High Court of Uttarakhand office premises, from the time of the Tender opening to the time the Contract is awarded.
- Any effort by a bidder(s) to influence High Court of Uttarakhand officers in the decisions on Tender evaluation, tender comparison or contract award may result in rejection of the Bidder's offer. If the Bidder wishes to bring additional information to the notice of the High Court of Uttarakhand, it should do so in writing.
- In case bidder(s) wants to furnish information regarding blacklist of other bidder(s), they have to provide documentary evidence for the same, without documentary evidence such representation shall not be entertained.

Rejection/Acceptance of Bids

Registrar General, High Court of Uttarakhand reserves the right to reject/accept any Tender, and to annul the bidding process and reject all the bids at any time prior to award of Contract, without thereby incurring any liability to the affected Bidder(s) or any obligation to inform the affected Bidder(s) of the grounds for such decision.

Award of Contract

- Award Criteria: The Criteria for selection shall be based on the evaluation criteria decided by High Court of Uttarakhand.
- The quantities may decrease or increase at any time, depending upon the requirements/grants available with the purchaser(s), which shall be binding to the bidder(s). The bidder has to supply the additional items on the rates given in the financial bid. The rates should be valid for 180 days.

In case, if the first bidder(s) (selected as per the criteria list) does not accept the award
of contract or is found to be involved in corrupt and/or fraudulent practices the next
bidder(s) in the list shall be awarded the contract as per suitable provisions provided in
the Uttarakahand Procurement Rules.

Force Majeure

- Force Majeure Events: The Force Majeure circumstances and events shall include the following events to the extent that such events or their consequences (it being understood that if a causing event is within the reasonable control of the affected party, the direct consequences shall also be deemed to be within such party's reasonable control) satisfy the definition as stated above. Without limitation to the generality of the foregoing, Force Majeure Event shall include following events and circumstances and their effects to the extent that they, or their effects, satisfy the above requirements:
- Natural events ("Natural Events") to the extent they satisfy the foregoing requirements including:
 - **a)** Any material effect of the natural elements, including lightning, fire, earthquake, cyclone, flood, storm, tornado, typhoon etc;
 - **b)** Explosion or chemical contamination (other than resulting from an act of war);
 - c) Epidemic such as plague;
 - d) Any event or circumstance of a nature analogous to any of the foregoing.
- Other Events ("Political Events") to the extent that they satisfy the foregoing requirements including:
- Political Events which occur inside or Outside the State of Uttarakhand or involve directly the State Government and the Central Government ("Direct Political Event"), including:
 - a) Act of war (whether declared or undeclared), invasion, armed conflict or act of foreign enemy, blockade, embargo, revolution, riot, insurrection, civil commotion, act of terrorism or sabotage;
 - **b)** Strikes, work to rules, go-slows which are either widespread, nation-wide, or state-wide and are of political nature;
 - **c)** Any event or circumstance of a nature analogous to any of the foregoing.
- Force Majeure Exclusions: Force Majeure shall not include the following event(s)
 and/or circumstances, except to the extent that they are consequences of an event of
 Force Majeure:
 - a) Unavailability, late delivery

- **b)** Delay in the performance of any OEM, sub-contractors or their agents;
- Procedure for Calling Force Majeure: The Affected Party shall notify to the other Party in writing of the occurrence of the Force Majeure as soon as reasonably practicable, and in any event within 5 (five) days after the Affected Party came to know or ought reasonably to have known, of its occurrence and that the Force Majeure would be likely to have a material impact on the performance of its obligations under the Agreement.

Contract Obligations

Once a contract is confirmed and signed, the terms and conditions contained therein shall take precedence over the Bidder's tender and all previous correspondence.

Amendment to The Agreement

Amendments to the Agreement may be made by mutual agreement by both the Parties. No variation in or modification in the terms of the Agreement shall be made except by written amendment signed by both the parties. All alterations and changes in the Agreement shall take into account prevailing rules, regulations and laws.

Use of Agreement Documents and Information

- The Bidder shall not without prior written consent from High Court of Uttarakhand disclose the Agreement or any provision thereof or any specification, plans, drawings, pattern, samples or information furnished by or on behalf of the High Court of Uttarakhand in connection therewith to any person other than the person employed by the Bidder in the performance of the Agreement. Disclosure to any such employee shall be made in confidence and shall extend only as far as may be necessary for such performance.
- The Bidder shall not without prior written consent of High Court of Uttarakhand make use
 of any document or information made available for the project except for purposes of
 performing the Agreement.
- All project related documents issued by the High Court of Uttarakhand other than the
 Agreement itself shall remain the property of High Court of Uttarakhand. The originals
 and all the copies shall be returned to the High Court of Uttarakhand on completion of
 the Bidder's performance under the Agreement.

Assignment & Sub Contracts

The Bidder shall not assign, in whole or in part, its rights and obligations to perform under the Agreement to a third party or a sub-contractor, except with the prior written consent from High Court of Uttarakhand. Such notification shall not relieve the Bidder from any liability or obligation under the Agreement. The Bidder shall fully indemnify High Court of Uttarakhand for any claims/damages whatsoever arising out of the Sub contracts.

Resolution of Disputes

- If any dispute arises between the Parties hereto during the subsistence or thereafter, in connection with the validity, interpretation, implementation or alleged material breach of any provision of the Agreement or regarding a question, including the questions as to whether the termination of the Contract Agreement by one Party hereto has been legitimate, both Parties hereto shall endeavor to settle such dispute amicably. The attempt to bring about an amicable settlement is considered to have failed as soon as one of the Parties hereto, after reasonable attempts [which attempt shall continue for not less than 30 (thirty) days], give 15 days' notice thereof to the other Party in writing.
- In the case of such failure the dispute shall be referred to a sole arbitrator or in case of disagreement as to the appointment of the sole arbitrator to three arbitrators, two of whom shall be appointed by both the Parties and the third may be appointed by the two arbitrators appointed by both the Parties.
- The place of the arbitration shall be Nainital, Uttarakhand.
- The Arbitration proceeding shall be governed by the Arbitration and Conciliation Act of 1996 as amended.
- The proceedings of arbitration shall be in English language.
- The arbitrator's award shall be substantiated in writing. The arbitration tribunal shall also decide on the costs of the arbitration procedure. The Parties hereto shall submit to the arbitrator's award and the award shall be enforceable in any competent court of law.

Terms of Execution & Delivery Time Schedule:

- The Bidder shall deliver the equipment within 3 weeks from the date of the Purchase order. In case of delay in delivery of equipments, penalty shall be charged as mentioned in LD (Liquidated Damages) clause.
- The Bidder shall complete the installation and configuration of the complete HCI solution within 3 weeks from date of delivery. Any delay beyond stipulated period shall attract

- additional penalty, as mentioned in the LD clause.
- Part of the week shall be considered as full week. Only business days would be calculated within the week, excluding holidays.
- The Bidder should have adequate number of qualified/certified and experienced resources with requisite skills required to manage the delivery/ Installation Setup as per the scope of the project.

Liquidated Damage Clause & Delivery Related Penalty

- Notwithstanding the High Court of Uttarakhand's right to cancel the order, liquidated damages at 0.5% of the cost of undelivered equipments per site per week shall be charged for every week's delay in delivery subject to maximum 5%.
- The Bidder shall complete the installation and configuration within 3 weeks from date of Installation & Commissioning. Any delay beyond stipulated period shall attract additional penalty @ 0.5% per week of order value maximum 5%.
- Maximum penalty is of 5% of order value excluding Annual Maintenance Charges (AMC).
- The High Court of Uttarakhand reserves its right to recover these amounts by any mode such as adjusting from any payments to be made by the High Court of Uttarakhand to the firms.
- However, the High Court of Uttarakhand may, at its discretion, waive the liquidated damages in case the delay cannot be attributed to the Bidder.

Taxes & Duties

Bidder shall be liable for all the taxes and duties etc. Bidder who does not hold a valid Permanent Account Number (PAN)/ Tax Identification Number (TIN) from Income Tax department, GoI and who is not registered under the GST prevalent in the State where his business is located shall not be eligible for biding. The GST Registration Number should be quoted and a GST clearance certificate from the Commercial Taxes Officer of the Circle concerned valid on the date of submission of tender shall be submitted without which the tender is liable to rejection. The bidder(s) quoting GST should have valid GST registration in the state of Uttarakhand and he should mention the same VAT/GST registration number in the tender document. GST must be shown separately.

 The income tax, service tax, etc., if applicable, shall be deducted at source from the payment to the Supplier/ Selected bidder(s) as per the law in force at the time of execution of contract.

- The entry tax, if applicable shall be deducted at source and deposited in the government treasury in proper revenue receipt head of account.
- For goods supplied from within India, the successful/ selected bidder(s) shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted Goods to the Purchaser.
- Revision in GST shall be on account of the tendering authority if it has been asked for separately in the financial tender and is not taken into account for the purpose of comparison of bids. If, however, they have not been asked for separately, any benefit or additional cost shall be on account of the bidder(s). Revision of any other tax or duty shall be on account of the bidder(s).

Books & Records

Bidder shall maintain adequate books and records in connection with Contract and shall make them available for inspection and audit by Government of Uttarakhand during the terms of Contract until expiry of the performance guarantee.

Insurance:

- The Goods supplied under the Contract shall be fully insured against loss by theft, destruction or damage incidental to manufacture or acquisition, transportation, storage, fire, flood, under exposure to weather and delivery at the designates project locations, in accordance with the applicable terms. The insurance charges shall be borne by the supplier and Purchaser shall not be required to pay such charges if incurred.
- The goods shall be delivered at the destination (FOR -> Freight on Road) in perfect condition.

Transportation

- The supplier/ selected bidder(s) shall be responsible for the proper packing so as to avoid damage under normal conditions of transport by sea, rail and road or air and delivery of the material in the good condition to the consignee at destination. In the event of any loss, damage, breakage or leakage or any shortage the bidder(s) shall be liable to make good such loss and shortage found at the checking/ inspection of the material by the consignee. No extra cost on such account shall be admissible.
- All goods must be sent freight paid through Railways or goods transport from the

supplier's/ selected bidder's bill.

Payments Terms

- The supplier's/ selected bidder's request for payment shall be made to the purchaser in writing, accompanied by invoices describing, as appropriate, the goods delivered and related services performed, and by the required documents submitted pursuant to general conditions of the contract and upon fulfillment of all the obligations stipulated in the Contract.
- Due Payments shall be made promptly by the purchaser, generally within sixty (60) days after submission of an invoice or request for payment by the supplier/ selected bidder(s), and the purchaser has accepted it.
- The currency or currencies in which payments shall be made to the supplier/ selected bidder(s) under this Contract shall be in Indian Rupees (INR) only.
- All remittance charges shall be borne by the supplier/ selected bidder(s).
- In case of disputed items, disputed amount shall be withheld and shall be paid only after settlement of the dispute.
- Payment in case of those goods which need testing shall be made only when such tests have been carried out, test results received conforming to the prescribed specification.
- Advance Payments shall not be made.
- Any penalties/ liquidated damages, as applicable, for delay and non-performance, as mentioned in this bidding document, shall be deducted from the payments for the respective milestones.
- Taxes (work contract tax, service tax, GST, income tax, etc.), as applicable, shall be deducted at source, from due payments, as per the prevalent rules and regulations.
