

Notice for Procurement of Computer Systems

This is to notify that, empanelled vendors of NIC (National Informatics Centre) are requested to submit techno-commercial proposals for supply, delivery, installation and commissioning of Computer Systems. Detailed specifications of Computer items to be procured has been mentioned at **annexure 'A'**. Total quantity of systems to be procured has been mentioned at **annexure 'B'**. Location for delivery, installation and commissioning, number of items to be procured has been mentioned at **annexure 'C'**.

Terms and Conditions:-

- A. The vendor must be an empanelled vendor of NIC (National Informatics Centre) and he must attach valid certificate of empanelment with NIC along with the proposal. The vendor must attach valid rate certificate of NIC with respect to pricing of hardware along with the proposal.
- B. The proposal must in two parts i.e. financial proposal and technical proposal. Both the proposals must be sealed by the vendor in separate envelopes and both these sealed envelopes shall be in bigger sealed envelope superscripting thereon "**Proposal for Procurement of Computer Systems**" and must reach the office of Registrar General, High Court of Uttarakhand, Nainital by 3.30 PM on or before 14.01.2016. The proposal received beyond the scheduled time shall be summarily rejected.
- C. The vendor must fill **annexure 'A'** (Part-1, Part-2 and Part-3) of notice completely. The vendor has to clearly mention deviations in corresponding specifications row (if any) under the deviation column.
- D. High Court of Uttarakhand will provide UBUNTU Operating System, customized by Hon'ble eCommittee, Supreme Court of India to selected vendor and vendor has to install the said OS into all Systems, before delivery, with all required drivers and plugins. It will be responsibility of vendor to check the compatibility of hardware with Operating System before delivery. The installation of Operating System (as mentioned in the specifications) will not affect the warranty.
- E. The selected vendor will deliver the items to each location defined at **annexure 'C'**. The order will deemed complete only after proper delivery, installation and commissioning.
- F. Terms of payment will also be as per mutually agreed terms between High Court and selected vendor as per the CVC guidelines and General Financial Rules.
- G. The selected vendor must complete the order in all aspect before closing of financial year 2015-2016. The dates will be mutually agreed between High Court and selected vendor.
- H. The vendor has to submit performance security for an amount of five (5) percent of the value of the contract. Performance security will be furnished in the form of an Account Payee Demand Draft, Fixed Deposit receipt from a commercial bank, Bank Guarantee from a commercial bank in an acceptable form. Performance Security should remain valid for a period of sixty days (60) beyond the date of completion of all contractual obligations of the supplier including warranty obligations.
- I. The terms and conditions detail page must be signed with stamp by the vendor.
- J. The proposed rates by vendor should not exceed the NIC approved rates.
- K. Any type of taxes should be separately mentioned by the vendor.
- L. Necessary certificates from Commercial Tax Department will be provided by the High Court to the selected vendor. The request for necessary certificate will be submitted by the selected vendor in advance.
- M. Other terms and conditions for delivery and performance of contract, will be mutually agreed upon terms between High Court and selected vendor.
- N. The procurement will be in accordance with the General financial Rules and Guidelines issued by CVC.
- O. In case of dispute, decision of Registrar General, High Court of Uttarakhand, will be final and binding.

Warranty & Penalty:

- A.** The selected vendor shall be fully responsible for the delivery, installation and commissioning of items in mutually agreed time frame between High Court and vendor. In failure of such conditions, a penalty of 0.5% of contract value per week will be charged, till the final delivery, installation and commissioning of items. These penalty charges will be deducted from the Performance Security.
- B.** The selected vendor shall be fully responsible for the manufacturer's Warranty for all equipment, accessories, spare parts etc. against any defects arising from design, material, manufacturing, workmanship, humidity, thundering or any act or omission of the manufacturer/Vendor or any defect that may develop under use of supplied equipment during the Warranty period.
- C.** During Warranty period, services such as equipment failure or any other fault whatsoever, which may arise, shall be attended Onsite by the selected vendor free of cost.
- D.** Call given by the authority, shall be attended by the selected vendor preferably within 24 hours and not beyond 48 hours in any case.
- E.** Any equipment i.e. reported to be defective or faulty should be either fully repaired or replaced by temporary substitute (of equivalent or higher configuration) within time prescribed.
- F.** In case the selected vendor fails to meet the above standards of maintenance during warranty period, a penalty of Rs. 200/ - (two hundred only) per day per item will be charged, till the equipment is fully repaired or replaced. These penalty charges will be deducted from the Performance Security.
- G.** Registrar General of High Court of Uttarakhand reserves all the rights to impose penalty as per above clauses and the decision of Registrar General of High Court of Uttarakhand will be final and binding.
