Hence, it shall be responsibility of bidder to collect the faulty device from user and get it repaired from OEM/nearby service centre and handover it back to user in shortest possible time. Further, the bidder must keep sufficient units of hand held devices and provide them as standby.

USB Type-C or micro-USB ports	Tender term shall prevail. However it must be clarified that the device must be 5G enabled. 5G/4G/3G doesn't mean that the device can support any one of them.
