Terms & Conditions for Onsite Comprehensive annual maintenance contract of 20 nos. water purifier machines (RO systems) and 01 no. Hot & Cold water purifier & 03 nos. high capacity water purifier:-

These are the terms & conditions for the Maintenance contract provider:-

- 1. This onsite comprehensive maintenance contract will be for 03 years. Rates will be quoted for a period of one year (with the condition that contract will be extended for next year, on the same rates, terms and conditions, if service of the firm will be satisfactory).
- 2. This AMC will include free replacement of all consumable spare/parts & electric parts (if required so) (original & genuine), change of filters twice in a year, one time changing membrane & second time replacing (if required so), 02 visits annually for 20 nos. non-commercial water purifiers and 04 visits annually (02 service visits & 02 preventive visits) for 04 nos. commercial water purifiers, additional visits as and when required. Any non-consumable parts will be changed on chargeable basis without service charges.
