AN ACT

Further to amend the Uttar Pradesh Krishi Utpadan Mandi Samiti (Alpkalik Vyavastha) Adhiniyam,1972

It is here by enacted in the fifty third year of the Republic of India as follows:-

- (i) This act may be called the Uttar Pardesh Krishi Utpadan Mandi Short title and Samiti(Alpkalik Vyavastha) (Uttaranchal Amendment) Adhiniyam, Commencement 2002
 - (ii) It shall be deemed to have come in to force on December 31, 2001
- 2. In section-2 of the Uttar Pradesh Krishi Utpadan Mandi Samiti (Alpakalik-Vyavastha) Adhiniyam,1972 here in after referred to as the principal Act, in sub Section (1), for the words and figures" till December 31, 2001" The words and figure" till December 31, 2002" shall be substituted.

 - (ii) Notwithstanding such repeal, any thing done or any a taken under the corresponding provisions of the principal Act amended by the Ordinance referred to in sub-section (1), she deemed to have been done or taken under the corresponding provisions of the principal Act, as amended by this Act, as a provisions of this Act where in force at all material times.
