NOTIFICATION

In exercise of powers conferred by sub-section (1) of section 25 read with section 24 of the Private Security Agency (Regulation) Act, 2005 (Act no. 29 of 2005) with a view to amend the Uttarakhand Private Agency Rules, 2022 the Governor, is pleased to allow to make the following rules, namely:-

The Uttarakhand Private Security Agency (Amendment) Rules, 2024

Short title and commencement 1 (1) These Rules may be called the Uttarakhand Private Security Agency (Amendment) rules, 2024.

(2) It shall come into force at once

Amendment of rule 2 In rule 4 of Uttarakhand Private Security Agency Rules, 2022,

4 (i) for the existing sub clause (a) of clause (IV) of sub rule (3) as set out in column I below, the rule as set out in column II shall be substituted, namely :-

Column I Existing rule	Column II hereby substituted rule
Uniform	(a) The guards and supervisors of the agency shall not wear uniforms (blue, khakhi, camouflage), similar to those of the Army, Paramilitary Forces and Police, but shall wear uniform of any other color in contrast to this and in the application form in this regard undertaking shall be obtained from the agency operator.

(ii) for the sub rule (7) as set out in column I below, the rule as set out in column II shall be substituted, namely:-

Column I Existing rule	Column II hereby substituted rule
(7) Save as provided in these rules the fees paid of a license shall be non-refundable	7(a) If, after having applied for the license, request to cancel the application is received, then the fees deposited by the applicant shall not be refunded.

	(b) Whereas, the online procedure has been adopted since 2020, therefore the abovesaid Rule 7(a) shall also be applicable in respect of fees deposited online.
	(c) The fees deposited by the applicants, whose licenses have either been rejected/not recommended either by the concerning District Magistrate/State Controlling Authority, shall not be refunded.

(iii) After sub rule (9) new sub-rule (10) shall be inserted as follows namely:-

“(10) for getting license under Uttarakhand Private Security Agency Rules 2022, only application forms of such firms shall be accepted in which the words “private security” is clearly mentioned, but for applications received before the notification of these amendment rules, the previous rules shall be applicable.”
