Be it enacted by the Uttarakhand Legislative Assembly in the Sixty-third Year of the Republic of India as follows:-

| <b>Amendment of<br/>section 161</b> | 2. After proviso of sub-section (1) of section 161 of the Uttar Pradesh Zamindari Abolition and Land Reform Act, 1950 (as applicable to the State of Uttarakhand), a new proviso shall be added as follows:<br>namely :- |

“Provided further that in such revenue villages where the notification is issued under section 4 of the Uttar Pradesh Consolidation of Holding Act, 1953, the provisions of first proviso shall not be applicable till three years from the commencement of such notification of section 53-A of the said Act.”
