2(अ) "पुलिस अधीक्षक" से सरकार द्वारा नियुक्त जिले का पुलिस अधीक्षक या वरिष्ठ पुलिस अधीक्षक अगिप्रेत है;

नियम 11 का : अन्तःस्थापन मूल नियमावली के नियम 10 के पश्चात् एक नया नियम 11 निम्नवत् अन्तः स्थापित कर दिया जायेगा, अर्थात—

वित्तीय अधिष्ठानों द्वारा रिपोर्ट एवं रिटर्न दाखिल करना

- 11 (1) प्रत्येक वित्तीय अधिष्ठान प्रपत्र-1 में वांछित सूचनाओं की रिपोर्ट सम्बन्धित जिलाधिकारी एवं पुलिस अधीक्षक को, जिसके अधिकार क्षेत्र में वित्तीय अधिष्ठान ने अपना व्यवसाय शुरू किया था या अपनाया था, दाखिल करेगा।
- (क) वित्तीय अधिष्ठान का यह दायित्व होगा कि प्रपत्र—1 में प्रस्तुत सूचना के सापेक्ष किसी भी परिवर्तन की रिपोर्ट परिवर्तन किये जाने के 07 दिन के भीतर सम्बन्धित जिलाधिकारी एवं पुलिस अधीक्षक को देनी होगी।
- (2) प्रत्येक वित्तीय अधिष्ठान वित्तीय वर्ष की प्रत्येक तिमाही की समाप्ति के एक माह के भीतर प्रपत्र—2 में अपने व्यवसाय के सम्बन्ध में वांछित सूचना, जिसमें उसकी वित्तीय स्थिति, इसके द्वारा जमा एकत्र किये जाने का क्षेत्र तथा इसके द्वारा राज्य के भीतर और वाहर धन के निवेश किये जाने की स्थिति में निवेश के स्थान की सूचना प्रत्येक तिमाही आधार पर सम्बन्धित जिलाधिकारी और पुलिस अधीक्षक, जिसके अधिकार क्षेत्र में व्यवसाय का कार्यक्षेत्र स्थित है, को प्रस्तुत किया जायेगा तथा यदि उसके व्यवसाय का कार्यक्षेत्र राज्य के एक से अधिक स्थानों पर स्थित हो, तो जिस जिलाधिकारी एवं पुलिस अधीक्षक के अधिकार क्षेत्र में उसके द्वारा घोषित मुख्य शाखा कार्यालय स्थित हो, को प्रस्तुत करेगा।

NOTIFICATION

In exercise of the powers conferred by Section 20 of The Uttarakhand Protection of Interests of Depositors (In Financial Establishment) Act, 2005, the Governor is pleased to make the following rules by partially amending The Uttarakhand Protection of Interests of Depositors (In Financial Establishment) Rules, 2015:-

The Uttarakhand Protection of Interests of Depositors (In Financial Establishment) (Amendment) Rules, 2018

Short title and commencement

- (1) These rules may be called The Uttarakhand Protection of Interests of Depositors (In Financial Establishment) (Amendment) Rules, 2018
 - (2) It shall come in to force at once.

Insertion Definition

- 2. In the Uttarakhand protection of Interests of Depositors (In Financial establishment) Rules 2015 (here in after referred as principal rules), Clause (h) shall be inserted after clause (g), namely:-
 - 2(h) "Superintendent of Police" means Superintendent of Police or senior Superintendent of Police of a district appointed by the Government.

Insertion Rule-11

3. In the Principal rules after rule-10, a new rule-11 shall be inserted as follows; namely:-

Filing of Report and Return by the financial Establishment

of

- 11. (1) Every Financial Establishment shall submit a Report in Form-I containing such particulars as required therein to the Collector and Superintendent of Police in whose jurisdiction the Financial Establishment commenced or carried its business.
- (a) It shall be the duty of every Financial Establishment to report to the Collector and Superintendent of Police, in case of any change in respect of any particulars furnished in Form-I, within seven days after the change has taken place.
- (2) Every Financial Establishment shall furnish, within one month of the expiry of each quarter of a financial year, a return in Form-II showing particulars in respect of its business including its financial position, the area of its deposit collected by it and the location of investments of moneys made by it within and outside the State, on each quarter of the financial year, if any, to the Collector and Superintendent of Police within whose jurisdiction his place of business is located, and if he has more than one place of business located in the State, to the Collector and Superintendent of Police under whose jurisdiction the main branch office, as declared by him, is located.
