NOTIFICATION

In exercise of the powers under section 111 and 211 of the Motor Vehicles Act, 1988 (Act no. 59 of 1988), the Governor, with a view to further ammending the Uttarakhand Motor Vehicles Rules, 2011, is pleased to publish the proposed Uttarakhand Motor Vehicles (Amendment) Rules, 2020, as required under subsection (1) of section 212 of the said Act for information of all concerned;

All concerned persons, who are likely to be affected by the proposed rules, are informed that objections and suggestion, if any with respect to the proposed rules may be sent in writing to Secretary, Parivahan Vibhag, Uttarakhand Shasan, 4 subhash Road, Dehradun within fifteen days from the date of its publication in the littarakhand State Gazette.

The Uttarakhand Motor Vehicles (Amendment) Rules, 2020

Short title and commencement 1.

- (1) These rules may be called the Uttarakhand Motor Vehicles(Amendment) Rules, 2020.
- (2) They Shall come into force with effect from the date of their publication in the Gazette.

Amendment 2. In the Uttarakhand Motor Vehicles Rules, 2011 for existing subrule of Rule 168 (4), (5) and (6) of rule 168 as set out in colum 1 below, the rule as set out in colum 2 shall be substituted and new subrule (7) (8) (9) shall be added as follows namely:-

Colum 1

(existing rule)

(4) "Green Card" shall be issued to the public service vehicles, engaged for the conveyance of passengers on religious tour on hill routes after the verification of its certificate of fitness, route permit, tax deposit certificate, insurance certificate and driving license.

"Green Card" is a document in which the detail of aforesaid document shall be mentioned.

Colum 2

(here by substitute rule)

(4) "Green Card" and "Trip Card" shall be issued to the public service vehicles, engaged for the conveyance of passenger on religious tour on hill routes after the verification of its certificate of fitness, route permit, tax deposit certificate, insurance certificate, pollution under control Certificate and driving license.

Explanation-for the purpose of this rule-

"Green Card" is a document in which the details of aforesaid documents of the concerned vehicle shall be mentioned.

"Trip Card" is a document in which the details relating to the concerned driving license and details of passengers travelling in the vehicle shall be mentioned.

- (5) Inspection of the vehicle shall be made in respect of the items specified in provision of rule 62 of the Central Motor Vehicles Rules, 1989 by senior motor vehicles inspector or motor vehicle inspector or any inspector authorized to discharge such the function before issuing the Green Card under sub-rule (4). Instructions Transport the State issued by Authority and Regional Transport Authority shall also be taken into account in such inspection after such inspection vehicles found fit shall be issued certificate of fitness carriage of passengers on religious tour on hill routes. Such certificates of fitness shall be issued by prescribed authority and its validity shall be two month.
- (6) Fee for every such inspection shall be the same as prescribed in rule 81 of the Central Motor Vehicles Rules. 1989. Provided that fee shall be charged for subsequent inspection within the same tour period.

(5) Procedure for online issue of Green Card and Trip Card shall be specified by the Transport Commissioner.

(6) Inspection of such public service vehicle in which seating capacity is more than ten seats including driver's seat shall be made in respect of the items specified in provision of rule 62 The Central Rules by senior motor vehicles inspector or motor vehicles inspector or any other inspector authorised discharge such functions before issuing the Green Card under sub-rule (4) instructions issued by the State Transport Authority and Regional Transport Authority shall also be taken into account in such inspection. inspection After such vehicles found fit shall be issued certificate of fitness for carriage of passengers on religious tour on hill . routes. Such certificates of fitness shall be issued by the prescribed authority.

Provided the physical inspection for issue of Green Card under sub-rule (4)

shall not be required in respect of such public service vehicles in which seating capacity is ten seats or less than ten seats including driver's seat.

Provided also that in any special circumstances registering authority may require production of vehicle and on such requirement the vehicle owner shall be bound to produce the vehicle for inspection.

- (7) The validity of Green Card issued under sub-rule (4) shall be up to 30th November each year or up to the date of validity of any document mentioned in sub-rule (4), whichever is less. The concerned applicant, while applying, shall mention the date from which Green Card shall be valid, in the application form.
- (8) Fee for every Green Card shall be as indicated below.
- (i) for light motor vehicle- RS. 400.00
- (ii) for medium motor vehicle- RS. 600.00
- (iii) for heavy motor vehicle- RS. 600.00

The aforesaid fee shall be paid online by the vehicle owner while submitting application for Green Card.

(9) The validity of Trip Card issued under sub-rule (4) shall be for one return trip for which no fee shall be payable.
