The High Court of Uttarakhand is pleased to amend the Rule 5 of the '*The Uttarakhand High Court Advocate Chamber Allotment & Occupancy Rules, 2008*' as under:-

<i>Existing Rule</i>	<i>Amended Rule</i>
5. Chamber shall not be allotted to a person, who already is in possession of a chamber, either allotted to him or otherwise, elsewhere in the State of Uttarakhand (other than Nainital town) or in the High Court premises at Allahabad or Lucknow. If, at any point of time, it is found or discovered that a statement, with respect to the applicant not having a chamber elsewhere in Uttarakhand or in Allahabad or Lucknow, is false, the allotment shall be cancelled, whereupon the allottee shall surrender the possession and vacate the Chamber.	5. Chamber shall not be allotted to a person, who already is in possession of a chamber, either allotted to him or otherwise, elsewhere in the State of Uttarakhand (other than Nainital town) or in the High Court premises at Allahabad or Lucknow. If, at any point of time, it is found or discovered that a statement, with respect to the applicant not having a chamber elsewhere in Uttarakhand or in Allahabad or Lucknow, is false, the allotment shall be cancelled, whereupon the allottee shall surrender the possession and vacate the Chamber. An advocate whose close relative (spouse /father /mother /son/daughter/father-in-law/mother-in-law) is already in possession of a Chamber, shall not be allotted a separate Chamber. Further, if two close relative advocates apply separately for the allotment of Advocate Chamber, only one of them, on the basis of seniority, shall be allotted a Chamber.
