The High Court of Uttarakhand is pleased to amend the Rule 13 of the 'The Uttarakhand High Court Advocate Chamber Allotment & Occupancy Rules, 2008' as under:-

### **Existing Rule**

### Amended Rule

- 13. Cancellation of allotment-The allotment of the Chamber to any allottee, before occupation after occupation, is liable to be cancelled on anyone of the following reasons and grounds;
- (i) If the allottee fails to pay the license fee by the  $15^{th}$  day of any succeeding month.
- (ii) If the allotee commits any breach of the Terms and Conditions of Allotment.
- (iii) If the allottee ceases to be a practicing Advocate on account of any reason whatsoever.

The allotment shall also come to an end in the event of the death of the allottee. On such happening, the vacancy in allotment shall be filled-up by making allotment in order of seniority to the wait-listed candidates, but preference shall be given to the legal heir of the allottee, if such legal heir is a practicing Advocate in the High Court of Uttarakhand at Nainital.",

- 13. Cancellation of allotment- The allotment of the Chamber to any allottee, either before occupation or after occupation, is liable to be cancelled on anyone of the following reasons and grounds:
- (i) If the allottee fails to pay the license fee by the 15<sup>th</sup> day of any succeeding month.
- (ii) If the allotee commits any breach of the Terms and Conditions of Allotment.
- (iii) If the allottee ceases to be a practicing Advocate on account of any reason whatsoever.

Where an allottee dies or retires from practice due to any incapacity or is elevated as a Judge and his/her name is deleted from the list of allottees, the application of his / her spouse /son / daughter/grandchild for allotment may be considered on preference basis, provided that the spouse /son / daughter/grandchild is a practicing Advocate in the High Uttarakhand at Nainital.

The amendment shall come into force with immediate effect.
