further to amend in the Uttarakhand Private Universities Act, 2023,

Be it enacted by the Uttarakhand Legislature in the Seventy-Sixth Year of the Republic of India as follows:-

- Short title and
 Commencement
- (1) This Act may be called the Uttarakhand Private Universities (Amendment) Act, 2025.
- (2) It shall come into force at once.
- Amendment of Section 19
- In the Uttarakhand Private Universities Act, 2023
 (hereinafter referred to as the principal Act), in section
 19, sub-section (1), for clause (c) the following clause shall be substituted, namely:-
 - (c) be ex-officio chairman of the Board of Management and the Academic Council.

In section 28 of the principal Act, after sub-section (2) the sub-sections numbered as sub-section (2) and sub section (3) shall be renumbered as sub-section (3) sub-section (4) respectively.

Amendment of

Section 42

4. In section 42 of the principal Act, in sub-section (1) for the words "Nationalized Bank" the words

"Nationalized/Scheduled Bank" shall be substituted.

If any difficulty arises regarding the establishment of Phonics University, Roorkee or Ethics University, Pauri Garhwal or The University of North West Himalayas, Dehradun or Shree Om University, Roorkee, then the State Government may, by order published in the Official Gazette, make such provisions, not inconsistent with the provisions of this Act, as appear to it to be necessary or expedient for removing the difficulty:

Provided that no such order shall be made after expiry of three years from the date of commencement of this Act.

(2) Every order made under sub-section (1) shall be laid before the State Assembly as soon as after it is made.

Saving

7. Notwithstanding such amendment anything done or any action taken under the principal Act shall be deemed to have been done or taken under the corresponding provisions of this Act.

Statement of Objective and reasons

To encourage the development of the State as an education hub and to promote private sector participation in the field of higher education, it has been decided by the state Government that private Universities with the name "Phonics University", Roorkee, "Ethics University", Pauri Garhwal, "The University of North West Himalayas", Dehradun and "Shree Om University", Roorkee shall be established.
