Sir/Madam.

On the subject cited above, I am directed to convey that it has been resolved by Hon'ble the Court that in the matter of registration and disposal of cases, and particularly of Execution Petitions, the following directions shall be complied:

- 1. Execution Petitions shall be registered only after due compliance of law. Where such compliance is deficient, the petitions shall be registered as Miscellaneous Cases till the requisite compliance is completed.
- **2.** In cases where the decree is required to be executed outside the territorial jurisdiction of the Court or in another State, the Petition shall be transferred in accordance with law.
- **3.** The Judicial Academy shall ensure targeted online training programs covering the procedural and legal aspects concerning registration and disposal of Execution Petitions.
- **4.** In order to ensure compliance with the mandate of the Hon'ble Supreme Court in *Periyammal (Dead Thr. Lrs.) v. V. Rajamani and Another etc.*, 2025 INSC 329, and to incentivize the disposal of targeted cases (both Civil and Criminal of APAaR-DJ) including all execution petitions, incentive of **2 Marks** shall be considered under *Category "C"* of Annexure-1 for disposal of targeted case, in continuation of C.L. No. 09/UHC/Admin.A/2024 dated 18 April 2024.

Your kind authority is accordingly requested to circulate these instructions among all judicial officers within their judgeships and to ensure meticulous compliance.
