Sub: Implementation of Fine Deposits under e-Pay System.

Sir/Madam,

The integration of the Fine Payment System (FPS) with the pooling account (operated at SBI Cyber Treasury Branch, Dehradun) linked to Government Treasury has been approved by the e-Committee, Hon'ble Supreme Court of India. The e-Pay system for fine payment has been successfully tested on the staging site for the District Courts of Bageshwar and Rudraprayag. The pilot implementation of e-Pay for fine payments in the two districts has been successful, and expansion to all district courts is contemplated.

2. Now, I am directed to convey that -

- (i) Fine payments in Magistrate/Criminal Courts of Districts may preferably be made through the e-Pay Online System (<https://pay.ecourts.gov.in/epay/>).
 - (ii) A weekly transaction report of such fine deposition (through e-Pay) is required to be reported to the Hon'ble Court (cpc-uk@aij.gov.in) during month of January, 2025 for observation (except District Courts of Bageshwar and Rudraprayag).
 - (iii) Concerned Courts shall reconcile the establishment-wise fine deposit report and duly certify it in the record book (Form No. 2) as per Chapter IX, Rule 71 and 82 of General Rules (Criminal), 1977.
3. Your kind authority is accordingly requested to circulate these instructions among all judicial officers to ensure smooth implementation of these initiatives aimed at digitization and efficiency enhancement in the judicial process.
