This is for information of all the members of the High Court Bar Association and all the concerned that Hon'ble the Chief Justice is pleased to nominate following Hon'ble Judge(s) of the Hon'ble High Court, as Vacation Judge(s) for Winter Vacation-2026, for the period, as mentioned against their respective names, who will exercise powers, as conferred under sub-rule (1) of the Rule 10 of Chapter-V of Allahabad High Court Rules, 1952 (as applicable to High Court of Uttarakhand, Nainital): -

2. The Vacation Court will sit on Tuesday and Thursday at 10:30 A.M. and it will take up only fresh urgent matters seeking interim orders in following class of cases: -

- (A)** Bail Applications
- (B)** Anticipatory Bail Applications
- (C)** Writ Petitions Criminal (WPCRL) for Protection Orders
- (D)** *Habeas Corpus* Petitions
- (E)** Matters seeking relief against eviction, ejectment, dispossession from property, or its demolition
- (F)** Matters seeking relief against attachment, auction or any other similar legal recourse affecting the property
- (G)** Matters seeking relief in respect of recruitment, selection, promotion or transfer order

(H) Matters seeking relief in respect of admission in educational institute, or in respect of examination conducted by such institute

3. In addition to above, Vacation Court may take up any other matter, which on being mentioned, is of such urgent in nature in the opinion of the Vacation Court that it can not wait till re-opening of the Court.
4. The Hon'ble Vacation Judge(s) may also hold the Court through Virtual Mode, in which case, V.C. link will be available in official website of the Hon'ble Court.
5. During the vacation, urgent matters, as mentioned above, will be filed in the filing counter for their listing on the following day. Filing will be on Monday and Wednesday from 10:30 P.M. to 1:30 P.M. Accordingly, cases filed on Monday will be listed on Tuesday and the cases filed on Wednesday, will be listed on Thursday.
6. The Hon'ble Vacation Judge(s) will hold the Court on every Tuesday and Thursday and if such Tuesday/Thursday is a holiday, the Vacation Court will sit on following working day *i.e.* Wednesday/Friday, and so on.
7. 26.01.2026 (Monday) being holiday on account of the Republic Day, fresh matters may be filed on 27.01.2026 (Tuesday) from 09:30 A.M. to 11:30 A.M., and the Vacation Court will sit at 11:30 A.M. to take up the matters
8. Further, fresh matters filed on 09.01.2026 and 10.01.2026 will be listed for the day, when the Hon'ble Court re-opens after the vacation *i.e.* on 09.02.2026, for which, cause list will be published on 06.02.2026, which is the last working day of the Registry during the winter vacation.
