Subject: Directives for Maximum Use of Roznama 2.0 (daily order sheet) Module  
and Digital Court 2.1 Application.

Sir/Madam,

In reference to the subject cited above, it is to inform that the Hon'ble e-Courts and Digitization Committee of the Hon'ble Court has considered the Detailed Project Report (DPR) of Phase-III of e-Courts Project that emphasizes smart case management systems built on machine-readable files to reduce court staff workload by minimizing data entry and eliminating manual entries and resolved that:

1. **Roznama 2.0 Module in CIS:** Courts may use the customizable and flexible digital "Roznama" module for daily orders instead of handwritten order sheet. CIS periphery has been developed for ease of Court business that can reduce the workload of court staff by minimizing the need to enter/upload data twice. A software patch for this purpose is being executed through System Officers/Assistant of the each District Court. The Judicial Academy shall organize training for Judicial Officers and staff, with actual workflow demonstrations of Roznama 2.0 in clusters of small Districts under the e-Committee outreach program.
2. **Digital Courts 2.1 Application for Commercial Courts:** Launched as a Green Initiative for paperless courts, this app (accessible via [https://digital.ecourts.gov.in/judges\\_v2/](https://digital.ecourts.gov.in/judges_v2/) through *Parichay* Login with Official e-mail IDs) allows Presiding Officers to view e-filed cases/documents, pleadings, and court orders. It offers Artificial Intelligence based speech-to-text, translation, transcript editing, and password-protected saving.

The resolution is duly approved by Hon'ble the Chief Justice. I am accordingly directed to request your kind authority to inform and sensitize the Presiding Officers of Commercial Courts about the Digital Courts Application and to start maximum use of Roznama 2.0 by all the Courts working on CIS.
