4. All the matters against orders/judgments of the Tribunals/Authorities/Commissions presided over by Former High Court Judges will be heard by Division Bench only.
5. Any other matter, not mentioned in this Roster, shall be listed as per the special or general directions of Hon'ble the Chief Justice.
