Sub: Listing of matters, when Hon'ble Judges do not hold the Court.

On the subject above, I am directed to say that in the interest of litigants, and for more convenient transaction of judicial business of the Hon'ble Court, Hon'ble the Chief Justice is pleased to give following directions for listing of matters pertaining to roster of Hon'ble Judges, when do not hold the Court.

FOR DIVISION BENCH-I

(A) When Hon'ble the Chief Justice does not hold the Court, fresh and date given matters pertaining to roster of DB-I will be listed as per the following arrangements:-

(i) From Monday to Wednesday before DB-III

(ii) On Thursday and Friday before DB-II

(B) Further, in the aforesaid situation, Hon'ble Shri Justice Subhash Upadhyay will sit single to take up single bench matters of His Lordship, including other matters, as assigned by Hon'ble the Chief Justice.

(C) When other member of DB-I (Hon'ble Shri Justice Subhash Upadhyay) does not hold the Court, Hon'ble Shri Justice Alok Mahra will sit in DB-I. In such situation, fresh and date given matters pertaining to single bench roster of His Lordship will be listed before Hon'ble Shri Justice Ashish Naithani.

FOR DIVISION BENCH-II

(D) When Hon'ble Shri Justice Manoj Kumar Tiwari or Hon'ble Shri Justice Pankaj Purohit does not hold the Court, fresh and date given matters of DB-II will be listed before DB-III (on sitting days of DB-III), otherwise the matters will be listed before DB-I. Further, the Hon'ble Judge, who holds the Court, will sit single to take up matters pertaining to single bench roster of His Lordship.

FOR DIVISION BENCH-III

(E) When Hon'ble Shri Justice Ravindra Maithani or Hon'ble Shri Justice Siddhartha Sah does not hold the Court, fresh and date given matters of DB-III will be listed before DB-II (on sitting days of DB-II), otherwise the matters will be listed before DB-I. Further, the Hon'ble Judge, who holds the Court, will sit single to take up matters pertaining to single bench roster of His Lordship.

FOR SINGLE BENCHES

(F) When Hon'ble Shri Justice Manoj Kumar Tiwari does not hold the Court, fresh and date given matters pertaining to single bench roster of His Lordship will be listed before Hon'ble Shri Justice Pankaj Purohit, and the matters will be listed before Hon'ble Shri Justice Manoj Kumar Tiwari, in the situation *vice versa*.

(G) When Hon'ble Shri Justice Ravindra Maithani does not hold the Court, fresh and date given matters pertaining to single bench roster of His Lordship will be listed before Hon'ble Shri Justice Siddhartha Sah, and the matters will be listed before Hon'ble Shri Justice Ravindra Maithani, in the situation *vice versa*.

(H) When Hon'ble Shri Justice Alok Kumar Verma does not hold the Court, fresh and date given matters pertaining to single

bench roster of His Lordship will be listed before Hon'ble Shri Justice Rakesh Thapliyal, and the matters will be listed before Hon'ble Shri Justice Alok Kumar Verma, in the situation *vice versa*.

(I) When Hon'ble Shri Justice Ashish Naithani does not hold the Court, fresh and date given matters pertaining to single bench roster of His Lordship will be listed before Hon'ble Shri Justice Alok Mahra, and the matters will be listed before Hon'ble Shri Justice Ashish Naithani, in the situation *vice versa*.

(J) When Hon'ble Shri Justice Subhash Upadhyay does not hold the Court and its Friday, fresh and date given matters pertaining to single bench roster of His Lordship will be listed before Hon'ble Shri Justice Siddhartha Sah.

MISC.

(K) In the aforesaid situations, other matters will remain stand out. However, urgency may be mentioned before the Bench, where the respective fresh matters are listed, and the Bench may accordingly take up the matters.

(L) In situations not covered under aforesaid arrangements, matters will be listed as per the general or specific directions of Hon'ble the Chief Justice.

(M) This Office Memorandum has the immediate effect, and it will supersede all the previous Office Memorandums, issued on the subject.
