Apropos to above and in continuation with earlier CL No. 8/UHC/Admin.B/2025 dated 30.06.2025 of the Hon'ble Court on the subject, kindly find enclosed herewith copy of order dated [13.03.2026](#) of the Hon'ble Court passed in AO No. 21 of 2024 titled as "*Hargovind Singh versus New India Insurance Co Ltd.*", wherein the Hon'ble Court has been pleased to observe as under:-

"This Court has called for the LCR in this appeal on 26.02.2026. It has to come from Nainital court only, but office report shows that it has yet not come. It is too strange.

Let a copy of this order be sent to the concerned Tribunal so that LCR may be forwarded to this Court immediately.

The Court requests the Registrar General of this Court to issue necessary directions to the concerned courts as well as the Registry to ensure that the record is received on time so as to avoid any adjournment in the matter."

2. In view of above, I am directed to convey following directions of the Hon'ble Court for the strict compliance:-

- a) Wherever a direction is issued by the Hon'ble High Court calling for the Trial Court Record (TCR) in any appeal, revision, or other proceeding, the concerned Section of the Registry shall forthwith issue requisition to the concerned Trial Court or Tribunal.
- b) Upon receipt of the requisition, the concerned Trial Court/Tribunal shall immediately send the TCR to Hon'ble

Court, and the scanned copy of the TCR or the physical copy shall be provided, as per the request in requisition.
