No.67/XV-1/24/7(14)/22--In exercise of the power conferred by sub-section (1) of section 13 of Uttarakhand Protection of Cow Progeny Act, 2007, read with section 21 of Uttar Pradesh General Clause Act (as applicable in state of Uttarakhand), 1904, the Governor is pleased to make the following rules with view to further amend the Uttarakhand State Protection of Cow Progeny Rules, 2011.

**The Uttarakhand State Protection of Cow Progeny (Amendment) Rules, 2024**

Short title and commencement:

1.(1) These rules may be called the Uttarakhand State Protection of Cow Progeny (Amendment) Rules, 2024.

(2) It shall come into force at once.

Amendment of Rule 29:

2. In the Uttarakhand State Protection of Cow Progeny Rules 2011, for the existing rule 29 as set out in column-1 below rule as set out in column-2 shall be substituted; namely-

29.(1) All the applications shall be examined by competent authority. After examination of all the issues related to these applications by the competent authority the following committee shall select the organizations for grant of Government aid :-	All the applications shall be examined by the District Magistrate through the nominated officer. (f) Head of Department, Department of Animal husbandry, Uttarakhand -Member Secretary	(f) Chief Veterinary Officer- Technical Member
(g) Secretary, Uttarakhand GauSewaAyog - Member	(g) District Development Officer- Member
(h) Secretary, Uttarakhand Animal Welfare Board - Member	(h) District Panchayati Raj Officer- Member
	(i) Divisional Forest Officer-Member
