



संख्या का०आ० 26/के०अ० 42/2005/धा० 4/2018.— महात्मा गांधी राष्ट्रीय ग्रामीण रोजगार गारन्टी अधिनियम 2005 (2005 का केन्द्रीय अधिनियम 42), की धारा 4 की उपधारा (1) द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, हरियाणा के राज्यपाल, इसके द्वारा, हरियाणा ग्रामीण रोजगार गारन्टी स्कीम, 2007, को आगे संशोधित करने के लिए निम्नलिखित स्कीम बनाते हैं, अर्थात्:—

1. यह स्कीम हरियाणा ग्रामीण रोजगार गारन्टी (संशोधन) स्कीम, 2018, कही जा सकती है ।
2. हरियाणा ग्रामीण रोजगार गारन्टी स्कीम, 2007 (जिसे, इसमें, इसके बाद, उक्त स्कीम कहा गया है) में, अध्याय-1 में, पैरा 2 में, उप-पैरा (च) में, "संयुक्त सचिव" शब्दों के स्थान पर, "संयुक्त निदेशक" शब्द प्रतिव्यापित किए जाएंगे ।
3. उक्त स्कीम में, अध्याय-iv में, पैरा 34 में,—
  - (i) उप-पैरा (1) में, "सचिव, ग्रामीण विकास" शब्दों तथा चिह्न के स्थान पर, "निदेशक, ग्रामीण विकास विभाग" शब्द तथा चिह्न प्रतिस्थापित किया जाएगा; तथा
  - (ii) उप-पैरा (2) के स्थान पर निम्नलिखित उप-पैरा प्रतिस्थापित किया जाएगा, अर्थात् :—
    - (2) "संयुक्त निदेशक, ग्रामीण विकास विभाग, स्कीम से संबंधित सभी मामलों में आयुक्त को सहायता देगे ।"

**Notification**

**No. S.O. 26/C.A. 42/2005/S. 4/2018.**— In exercise of the powers conferred by Sub-section (1) of Section 4 of the Mahatma Gandhi National Rural Employment Guarantee Act, 2005 (Central Act 42 of 2005) the Governor of Haryana hereby makes following amendments in the Haryana Rural Employment Guarantee Scheme, 2007, namely:-

1. This Scheme may be called the Haryana Rural Employment Guarantee (Amendment) Scheme, 2018.
2. In the Haryana Rural Employment Guarantee Scheme, 2007(hereinafter called the said Scheme), in chapter-1, in para 2, in sub-para (1), for the words "Joint Secretary", the words "Joint Director" shall be substituted.
3. In the said scheme, in chapter-V, in para 34,-
  - (i) in sub-para (1), for the words and sign "Secretary, Rural Development", the words and sign "Director, Rural Development Department" shall be substituted;
  - (ii) for sub-para (2), the following sub-para shall be substituted, namely:-
    - (2) "Joint Director, Rural Development Department shall assist the Commissioner in all matters pertaining to the scheme."
