Sub:- Action regarding implementation of Gram Samridhi Evam Swachhata Pakhwada.

Please refer to the subject noted above.

Since you are the District Nodal Officer for this Mission Antyodaya Gram Samridhi Evam Swachhata Pakhwada to be celebrated from 01.10.2017 to 15.10.2017 many action are to be taken for making it successful. It is expected the Block Level Nodal Officers and the Gram Panchayat Level Nodal Officers for each GPs have been appointed. The status may please be appraised by 15th September, 2017. There will be one component during the Pakhwada stressing on the IEC activities which consists of displaying the details of the scheme/programmes implemented by the Govt. on hoardings, wall paintings, posters, etc.. The sample material for few schemes are available at www.haryanarural.gov.in for download. Tentatively this activity should be completed between 28-30 September, 2017. The Gram Sabha will be convened on Gandhi Jayanti on 2nd October, 2017 in which the maximum participation of the people is required so that the performances and planning of different schemes can be done. A massive campaign to motivate the public for participation and their proactive role for getting better village development plan is to be done. For this purpose village level motivators, SMS, radio, FM and other media can be used. The local leaders may also be involved for motivating public. Third the sanitation drive is to be conducted during the programme, for this purpose the campaign involving village people and SHGs of various departments/ANM/Asha workers/Anganwadi workers etc., school children be done of 1st October, 2017.

It is important to inform that the GP level Nodal Officers or Panchayats Secretaries will take the pictures/clips of the events and will upload on the MoRD portal from their mobiles through



“Swachh Gram” mobile application. The mobile application can be downloaded easily from the google play store as well as web portal of <http://swachhgram.nic.in> shortly. They also have to fill the details of the activities conducted during the programme in the formats (questionnaire at annexures I & reporting at IV) of the Ministry for uploading from the web portal of <http://swachhgram.nic.in>. The district level resource person will be identified and inform to get the training who will further give training to Block Level resource person to help the GP level functionaries.

The another aspect of the Pakhwada is Mission Antyodaya Gram Panchayats of the State. In these Gram Panchayats a survey of households would be carried out by the SHGs or CRPs and they will upload the information in another mobile application of the Ministry “Samridh Gram” after getting vetted. Training and other formalities will be carried out for this purpose from the CEO, HSRLM who is State Nodal Officer for this survey.

You are requested to send the action taken so far on above points by 15th September, 2017 and, thereafter, further action taken from time to time at drd@hry.nic.in and gaurhamesh@gmail.com to apprise the PSRD for overall supervision and to the Ministry.


