

It has been decided that all the Gram Panchayats shall conduct Gram Sabha meetings on 2nd October 2017. Following activities shall be taken up for celebration of Gram Samridhi Evam Swachhata Pakhwada celebration between 01.10.2017 to 15.10.2017 :-

1. The publication of the progress and details of various schemes/departments on hoardings, wall paintings, posters etc. is to be done in all Gram Panchayats between 28-30 September, 2017.
2. The Panchayats Secretaries will be the GP Level Nodal Officer.
3. The DCs will nominate Block Level Nodal Officers for the programme.
4. District & Block Officers will publish the programme as per the provisions of the Act & Rules. Maximum efforts using advertising the schedule alongwith with time and venue in the local newspapers well in advance, munadi etc are to be done so that there is huge participation of the public in the Gram Sabha.
5. It shall be ensured that representatives of each department is present during the Gram Sabha meeting. Line department officers/ official shall be conveyed the programme of the Gram Sabha meeting well in advance.
6. Events with photographs & Clips shall be recorded in the mobiles and uploaded on www.swachhgram.nic.in webportal of the ministry from each Gram Panchayat by Nodal Officers.
7. The GP Level Nodal Officers will also fill the formats annexure I and IV of the guideline of the Pakhwada and upload on the webportal www.swachhgram.nic.in.




