#### **1. Mahatma Gandhi National Rural Employment Guarantee Scheme**

##### **Funding Pattern : Centre 90% and State 10%**

Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) is being implemented in all the districts of Haryana State from the year 2008-09.

##### **OBJECTIVE**

The basic objective of the scheme is to enhance livelihood security in rural areas by providing atleast 100 days of guaranteed wage employment in a financial year to every rural household whose adult members volunteer to do unskilled manual work.

An outlay of Rs.400.05 crore has been approved as Centre & State share for the Annual Plan 2023-2024.

**2. National Rural Livelihoods Mission (NRLM)/Aajeevika**  
**Funding Pattern: 60% Centre & 40% State**  
**Phasing**

The National Rural Livelihood Mission was started w.e.f 01-04-2013 and implemented in phased manner in all the districts of the State. Now whole state is covered. The aim of the mission is to reduce poverty in rural areas through building their strong Community Based Organizations (CBOs) e.g. Self Help Groups (SHGs), the Village Organization, Cluster Federation and facilitate them to access financial as well as livelihoods opportunities in order to come out of poverty.

During 2022-23 under this scheme, 8685 SHGs have been formed and an amount of Rs.66.01 crore has been spent under the scheme including grants to Self Help Groups (SHGs), the Village Organization (VOs), Cluster Level Federations (CLFs).

During 2023-24 (upto 05.12.2023), 4721 SHGs have been formed and an amount of Rs.29.70 crore has been spent under the scheme including grants to Self Help Groups (SHGs), the Village Organization (VOs), Cluster Level Federations (CLFs) under this scheme.

**Deen Dayal Upadhaya- Gramin Kaushal Yojana (DDU-GKY)**

This scheme is for providing training and placement to rural poor youth of India. This scheme was started in 2014-15 in the State. The cost related to training and placement subscribed as Common Cost Norms are allowed under the programme and the funds are calculated as per the targets allocated to a project. The scheme works on a People Project Partnership (PPP) model and the funds are routed through the State Rural Livelihood Mission.

During 2022-23, an amount of Rs.27.49 crore has been incurred and 5945 candidates have been trained.

During 2023-24 (upto 05.12.2023), an amount of Rs.19.86 crore has been incurred and 6093 candidates have been trained.

**Start-up Village Entrepreneurship Programme (SVEP)**

This is a sub scheme of NRLM is for helping rural poor youth to start and support rural enterprises. The overall objective of SVEP is to implement the Government's efforts to stimulate economic growth and reduce poverty and unemployment in the villages by helping start and support rural enterprises. During 2022-23, an expenditure of Rs.1.81 Cr. has been incurred and 780 enterprises have been promoted and during 2023-24 (upto 05.12.2023), an expenditure of Rs.0.03 Cr. has been incurred.

An amount of Rs. 200.40 crore has been approved as Centre (60%) & State (40%) share under DAY-NRLM, SVEP & DDU-GKY and Rs.5.00 crore as 100% Centre share under R-SETI scheme for Annual Plan 2023-2024.

### **3. Pradhan Mantri Krishi Sinchayee Yojana erstwhile-Watershed Management Programm (IWMP/ Now PMKSY)**

The programme is mandated to restore the ecological balance by harnessing, conserving and developing degraded natural resources such as soil, vegetative cover and water. The outcomes are prevention of soil erosion, regeneration of natural vegetation, rain water harvesting and recharging of the ground water table. This programme is being implemented in 8 districts of the state. 9 Projects of Centrally Sponsored Programme amounting to Rs.80.59 crore under New Generation Watershed Projects have been sanctioned by the Government of India during 2021-22. This scheme will be implemented in the Period of next 5 years five districts of the state i.e. Bhiwani, Charkhi Dadri, Gurugram, Mahendragarh and Y/Nagar.

During 2022-23, an amount of Rs.8.52 crore has been incurred on various activities in these Watershed Projects and during 2023-24 (upto 05.12.2023), an amount of Rs. 8.63 crore has been incurred on various activities in these Watershed Projects.

An outlay of Rs.40.00 crore has been approved as Centre share and State Share for the year 2023-2024.

### **4. Member of Parliament Local Area Development Scheme (MPLADS) Funding Pattern: 100% By Central Govt.**

This scheme has been launched by Govt. of India from, 23 December, 1993. Under this scheme, Govt. of India provides to each M.P. an amount of Rs.5.00 Crore per annum for the development works. The Ministry has now released the latest revised guidelines on MPLADS and a revised procedure for fund flow is to be adopted from 01.04.2023.

#### **Major Objective:-**

1. Construction of building for Schools, Hostels, Libraries and others buildings of educational institutions. Construction of tube wells and water tanks.
2. Construction of roads including part roads, approach roads, link roads etc.
3. Special forestry, farm forestry, horticulture, pastures, parks and gardens in Government and Community lands or other Surrendered lands.
4. Construction of public toilets and bathrooms.
5. Construction of bus sheds/stops for public transport passengers.
6. Construction of drains and gutters, footpaths, pathways and footbridges.
7. Construction of veterinary aid centers, artificial insemination centers and breeding centers.
8. Construction of road under Railway Bridge, Road, Approach Road to Railway Station.
9. Construction of additional Toilet for passengers in Circulation Area of Railway Station. Provision of Drinking Water in station premises.
10. Construction of playfields Sports Facilities at village-level/ block-level.
11. Construction of Multi-Purpose Hall for Games.
12. Construction of veterinary Hospitals and Dispensaries.
13. Construction of Farmer's Training and Assistance Centres.
14. Construction of Soil Testing Laboratories subject to the condition that no consumables will be allowed.
15. Construction of Dining Hall and Kitchen with fixed Purifier and solar Geyser for Mid-Day Meal Scheme.
16. Construction of footpaths/pedestrian ways and community toilets in the urban areas.

During 2022-23, an amount of Rs.27.21 crore has been incurred and 177 works have been completed and during 2023-24 (upto 05.12.2023), an amount of Rs.25.23 crore has been incurred and 445 works have been completed.

**5. Vidhayak Adarsh Gram Yojana now Vidhayak Adarsh Nagar Avam Gram Yojana (VANGY)**

**Funding Pattern : 100% State**

The State Govt. launched Vidhayak Adarsh Gram Yojana (VAGY) for the holistic development of villages identified by the Hon'ble MLAs of the State. Under this scheme, the State Govt. has decided on 26.12.2018 that an amount of Rs.2.00 crore will be provided for each constituency every year. This amount can be spent in one or more villages. However, for every individual village, the amount shall be limited to only one of the three amounts i.e. Rs.50.00 lacs for the village having population of 5000 and Rs.1.00 crore for village having population more than 5000 but less than 10000 and Rs.2.00 crore for village having population more than 10000.

Now the scheme has been renamed as Vidhayak Adarsh Nagar Avam Gram Yojana (VANGY). Hon'ble MLAs can execute Development works in urban areas like Nagar Nigam, Nagar Parishads and Nagar Palika in apart from those of Rural Areas.

Under this scheme, an outlay of Rs.180.20 crore has been approved as State share for the year 2023-24.

**6. Pradhan Mantri Adarsh Gram Yojana**  
**Funding Pattern : 100% Centre**

The Ministry of Social Justice and Empowerment has introduced the PMAGY during the year 2014-15 in 12 villages of Faridabad & Palwal districts of the State. The main objective of the scheme is to ensure integrated development of the selected villages with more than 50% SC population into "model villages". Now, as per the notification issued vide dated 15<sup>th</sup> June, 2023 by the Ministry, the villages with more than 40% SC population are to be selected under the scheme. The Ministry is providing Rs.20.00 lakh per village for the integrated development of selected villages under this scheme.

From the year 2018-19 (Dec., 2018), this scheme is being implemented in all the districts of the state and 352 villages have been identified from the year 2018-19 to 2021-22 by the Ministry. Out of total identified villages, the Village Development Plan of 201 villages has been prepared. During the year 2022-23, 285 more villages have also been identified by the Ministry.

9 villages of districts Faridabad(6) and Palwal(3) of phase-I and 28 villages of various districts of phase-II have been declared as Adarsh villages.

- During 2022-23, an amount of Rs.1.31 crore has been utilized.
- During 2023-24 (upto 05.12.2023), an amount of Rs.0.02 crore has been utilized.

Under this scheme, an outlay of Rs.10.00 crore has been approved as Centre share for the year 2023-24.

## **7. Shyama Prasad Mukherji Rurban Mission (SPMRM)** **Funding Pattern : 60% Centre & 40% State**

Hon'ble Prime Minister, Govt. of India launched Shyama Prasad Mukherji Rurban Mission (SPMRM) on 21<sup>st</sup> February, 2016. The Mission aims at development of rurban clusters, which would trigger overall development in the region. The clusters would be developed by provisioning of economic activities, developing skills & local entrepreneurship and providing infrastructure amenities.

### **Selection of Cluster**

A Rurban cluster, would be a cluster of geographically contiguous villages with a population of about 25,000 to 50,000 in plain and coastal areas and with a population of 5000 to 15000 in desert, hilly or tribal areas. Clusters of villages would follow administrative convergence units of Gram Panchayats and shall be within a single block/tehsil for administrative convenience.

### **Selected Cluster**

The Ministry of Rural Development, Govt. of India selected 10 clusters for Haryana State in the following districts during the year 2016-17 & 2017-18:-

### **Achievements**

Under this scheme, 150 villages have been covered under all the 10 clusters selected by the Ministry in Phase-I, II & III and total numbers of 1974 works have been undertaken since inception out of which 1438 works have been completed in these villages.

During 2022-23, an amount of Rs.85.35 crore has been utilized and 156 works have been completed.

During 2023-24 (upto 05.12.2023), an amount of Rs.12.21 crore has been utilized and 209 works have been completed.

Under this scheme, an outlay of Rs.50.00 crore has been approved as Centre & State Share for the year 2023-24.

#### **8. Swaranjayanti Khand Utthan Yojana (SKUY)** **Funding Pattern: 100% State**

This scheme has been started by the State Govt. to address the developmental imbalances, socio economic imbalances in development process. This Yojana will be implemented initially in the 20 backward blocks in the 1<sup>st</sup> phase of the state. The broadly feature of the scheme is with the objectives to bridging the gaps in local infrastructural and development requires that cannot be made through existing schemes, to improve livelihood opportunities through skill development programme in convergence with other schemes, skill development design & marketing support in convergence with other departments, to ensure adequate flow of funds to these identified blocks through special component in the normal existing schemes.

Under this scheme, 20 Blocks have been identified as backward blocks in 1<sup>st</sup> phase in 8 districts namely Bhiwani (Loharu, Behal, Siwani& Kairu), Charkhi Dadri (Badhra), Kaithal (Guhla), Mewat (Nuh, Punhana, Taoru, Nagina & Ferozepur Jhirka), Palwal (Hathin), Panchkula (Morni, Pinjore, RaipurRani&Barwala), Rewari (Rewari & Bawal) and Y/Nagar(Sadaura & Chhachhrauli). The State Govt. has released funds amounting to Rs.20.00 lacs for each identified block for the preparation of Block Action Plan. The Block Development Plans of all the identified 20 blocks have been prepared by the concerned districts. An amount of Rs.15.00 crore (as 1<sup>st</sup> installment) has been released during FY 2023-24 to all the concerned districts for the execution of the approved works as per the Block Development Plan (BDP).

Under this scheme, an outlay of Rs.60.00 crore has been approved as State Share for the year 2023-24.

#### **9. Pradhan Mantri Jan Vikas Karyakram(PMJVK)** **Funding Pattern: Centre 60% and State 40%**

The Ministry of Home Affairs, GoI started Multi-Sectoral Development Programme in the year 2008-09 and scheme was restructured as "Pradhan Mantri Jan Vikas Karyakram (PMJVK)" w.e.f.

01.04.2018 to address the development deficits of the identified Minority Concentration Areas. The areas for implementation of PMJVK has been identified on the basis of substantial population of minority communities i.e. 25% of minority population in the area and backwardness parameters in the area concerned which are below the national average on the basis of the Census-2011.

Under this scheme, infrastructure will be created to improve the quality of life of people and to reduce the imbalances in the identified minority concentration areas to be at par with the rest of the country. 80% of the resources would be utilized for projects related to education, health and skill development of which at least 33-40% will be earmarked for creation of assets/facilities for women/girls. The scheme focused on converging existing infrastructure under different programmes of Government of India along with newly taken up innovative projects. In Haryana State, the following 15 blocks of 7 districts have been identified to develop socio-economic assets and basic amenities in the area:

As per the new guidelines issued by the Ministry during 2022-23, this programme will be implemented in all the districts of the state in area where the concentration of minority population is more than 25% in the catchment area (15 km radius).

### **Achievements**

- During the year 2022-23, an amount of Rs.6.72 crore has been utilized.
  - During 2023-24 (upto 05.12.2023), an amount of Rs. 5.80 crore has been utilized.
- Under this scheme, the projects amounting to Rs.956.91 crore received from all the 7 districts have been sent to the Ministry of Minority Affairs, Govt. of India for their consideration and approval.

Under this scheme, an outlay of Rs.60.00 crore as Centre and State share has been approved for the year 2023-24.

**10. Matching Grant Scheme-in-Aid for Development Works- (Government Share)**  
**Funding Pattern: 100% State**

With a view to give incentive to take up development projects in rural and urban areas, the scheme of Matching Grant was introduced in 1979-80. This scheme is executed under specific rules for projects, namely school buildings, veterinary dispensaries, hospitals, recreation centres, mahila mandal bhawans, harijan and backward chaupals and other development works through Panchayat/ Panchayat Samitis, PWD (B&R) and Local Committees. The Matching Grant Scheme has been introduced to bridge the gap and enables the people to seek financial help equal to the amount raised by them as public contribution except in the case of girl's school, girl's colleges & hostels in the State, where the amount of grant is twice that of the contribution. This scheme has encouraged people's participation. The rural people themselves identify the projects and raise their public contribution and are associated throughout the implementation of the project. This scheme has evoked a big response from the people and every year there is an increase in the demand of this grant. Under this scheme, a budget provision of Rs.3 crore has been made by the State Government during the current financial year 2022-23, out of which an amount of Rs. 9.00 lacs has been sanctioned.

Under this scheme, a budget provision of Rs.3.00 crore has been made by the State Government during the current financial year 2023-24, out of which an amount of Rs. 2.00 crore has already been sanctioned.

**11. Scheme for State Level Task Force under SBM-G**  
**Funding Pattern : 100% State**

This scheme has been constituted as per the approval of the Hon'ble Chief Minister, Haryana. It will look-after the activities of SBM-G and SBM-U both. It includes a Chairman, Vice Chairman, 4 official members and 10 non-official members. Besides it, two more academicians / professional are to be nominated separately. An amount of Rs. 50.00 lakh has been made during the financial year 2022-23. The expenditure of SLTF will be borne by SBM-G and SBM-U in the ratio of 50:50. A budget provision of Rs. 1.00 Crore has been kept for the year 2023-24 to implement the Swachh Bharat Mission to make Swachh Bharat Mission a people's movement by involving NGOs for various works.

**12. Scheme for Financial Assistance to Haryana Rural Development Authority (HRDA)**  
**Funding Pattern : 100% State**

This is a State Plan Scheme introduced during the year 2007-08. The Govt. has constituted the Haryana Rural Development Authority to promote regulated growth in-and-around the villages. The intention of the scheme is to provide financial assistance to HRDA enabling it to provide urban like facilities including housing facilities, particularly for the weaker sections of the society, in the rural areas. The Authority has been set-up on the pattern of HSVP to provide basic amenities and residential facilities in villages and their peripheries. During FY 2022-23, an amount of Rs.11.04 crore has been spent for purchase of land i.e. 48Acre 1 Kanal 14 Marla of Village Israna Distt. Panipat to develop Model Colony. An amount of Rs.40.00 Crore has been approved for the FY 2023-24.



**13. Haryana Gramin Vikas Yojana (HGVY)**  
**Funding Pattern : 100% State**

This scheme came into existence in 1970-71. It was transferred by Social Welfare Department in the year 1991-92 to Development & Panchayats Department and in the year 2023-24 it was transferred to Rural Development Department.

The aim of this scheme is to provide a common platform to the communities for celebrating their community functions like marriages, festivals and to discuss the issues of common importance. The development of villages like pavement of streets, drains, community centres, cremation grounds, retaining wall of ponds etc, having population less than 10000 will be taken up under this scheme. Special Development Works Scheme has been merged in Haryana Gramin Vikas Yojana in the year 2022-23. An amount of Rs.100.01 crore has been approved for the year 2023-24 for implementation of Grey Water Management Projects under SBM-G.

**14. Haryana Swarn Jayanti Mahagram Yojana (SMAGY)**  
**Funding Pattern : 100% State**

Under this scheme sewerage system are laid down in the villages having population 10,000 or more than 10,000. Under this scheme only administrative approval for laying the sewerage system in a village is provided by the Rural Development Department. The funding/execution for all these projects is carried out by the Public Health Engineering Department (PHED). During the year 2023-24, an amount of Rs. 20 crore has been approved under the scheme.

**15. Mahatma Gandhi Gramin Basti Yojana Scheme**  
**Funding Pattern : 100% State**

This scheme provides the funds for annuity and funds for laying down the electricity and other facilities in the colony developed under the MGGBY Scheme. Fund of Rs 30 Cr. was approved during the year 2022-23. An amount of Rs. 7.44 crore (released on 20.06.2022) + 4.62 crore (released on 29.08.2022) were released as annuity funds in lieu of land utilization of the Gram Panchayats during the 2022-23. A Special Task Force has been constituted under the chairmanship of the Block Development & Panchayats Officer concerned to analysis the Bastis developed under this scheme. This committee will also conduct a survey of these bastis and will submit its report of the essential development needed.

During the current financial year i.e. 2023-24, an amount of Rs. 30 crore has been approved under this scheme, out of which an amount of Rs.13.45 crore has already been released.

Under this scheme, funds are released in two ways: first, annuity funds Rs. 10,000/- per acres are being released in lieu of land utilization for allotting the plots under the scheme. Secondly, the funds are released to the PHED, DHBVN and UHBVN as per demand for providing the basic facilities like of electricity, water etc in the Bastis development under this scheme.

**16. Haryana Gramin Vikas Yojana**  
**Funding Pattern : 100% State**

This is a State Plan scheme which came into existence in 1970-71. It was transferred by Social Welfare Deptt. in the year 1991-92 to Dev. and Panchayats Deptt. The aim is to provide a common platform to the communities for celebrating their community functions like marriages, festivals and to discuss the issues of common importance. The development of villages like construction of community centres, link roads between villages for width less than 5 karam, paths to fields under Mukhyamantri Kisan Khet Sadak Yojana, Phirnis, Rural Sports Stadium at villages level and Government may approve any other development works other than above will also be taken up under this scheme. The original outlay for the year 2023-24 is Rs. 700 crore. Supplementary budget grant has been approved to Rs. 500 crore and thus, revised outlay for the year 2023-24 is Rs. 1200.00 Cr. The budget allocation under this scheme is Rs. 784.48 crore during 2023-24 (upto 08.12.2023).

**17. Deenbandhu Gram Uday Yojana Scheme**  
**Funding Pattern : 100% State**

This scheme was launched for construction of Anganwadi, Village Knowledge Centre, Govt. Veterinary Hospital, and Govt. Veterinary Dispensary in the rural areas. An amount of Rs. 200 crore. was approved and Rs. 54.09 crore was released during the year 2022-23. A budget provision of Rs. 200 Cr. has been made during the current financial year 2023-24, out of which an amount of Rs. 30.00 Cr has been released. Under this scheme, funds are released as per the demand raised by the Executive Engineer through the Chief Engineer Panchayati Raj.

**18. Financial Assistance to Panchayat/ Panchayat Samitis Under Revenue Earning Scheme (R.E.S.)**  
**Funding Pattern : 100% State**

This plan scheme has been continuing since 1957-58 with a view to augment the financial position of the Gram Panchayat/ Panchayat Samitis in the State and to enable them to take up development works in their areas for the benefit of Panchayat/ Panchayat Samitis. Under this scheme interest free loan is given to Panchayat/ Panchayat Samitis for installation of Tube wells, Pumping sets on shamilat land, construction of shops at bus stand and construction of staff quarter etc. The loan is recoverable in 30 yearly instalments. No amount was released during the last financial year 2022-23.

Under this scheme, a budget provision of Rs. 2 Cr. has been made by the State Government during the current financial year 2023-24. Under this scheme, funds in lieu of loan are sanctioned to the Gram Panchayat/Panchayat Samiti as per the demand raised by the Gram Panchayat/Panchayat Samiti concerned.

**19. Swachh Bharat Mission Grameen (SBM-G)**  
**Funding Pattern: Centre 60% and State 40%**

The Government of India, Ministry of Jal Shakti has approved SBM-G Phase-II which will be implemented from 2020-21 to 2024-25. The key objective of SBM-G Phase-II is to sustain the ODF status of villages and improve the levels of cleanliness in rural areas through solid and liquid waste management activities, making villages ODF Plus.

Under the programme, incentive up to Rs. 12,000 is permissible for eligible households for construction of Individual Household Latrine (IHHL), Rs. 3 lakh per Community Sanitary Complex (CSC) is being provided to the GPs for construction of CSC at village level. 30% of this amount will be borne by the GPs from their 15th Finance Commission grants.

Financial support of Rs. 60/- per capita for Solid Waste Management and Rs.280/- per capita for Grey Water Management would be provided for a village having population upto 5000 while Rs. 45/- per capita for Solid Waste Management and Rs.660/- per capita for Grey Water Management would be provided for a village having population more than 5000. However, 30% of this amount will be borne by the GPs from their 15th Finance Commission grants.

For GOBAR-DHAN project, Rs. 50 lakh per district is permissible under the programme while Rs. 16/- lakh for Plastic Waste Management Unit (PWMU) is permissible (one unit in each block). For Faecal Sludge Management up to Rs. 230/- per capita is permissible under the programme.

Swachh Bharat Mission-Grameen is a Centrally Sponsored Scheme funded by Central and the State Government in the ratio of 60:40. A budget provision of Rs. 167 Cr. has been earmarked for the year 2023-24 and an amount of Rs. 41.67 Cr. has been utilized (up to 07-12-2023) under the scheme.
