GOVERNMENT OF HARYANA
FOREST DEPARTMENT
ORDER

In the CWP No. 20245 of 2014 filed by Sh. Subhash Chander Yadav, HFS in the Hon'ble Punjab and Haryana High Court, he prayed for preparation of year wise seniority list of Haryana Forest Service (Group-B) officers w.e.f. 01.01.2003 to 01.01.2014 by the respondents (State) assigning the quota of promotee and direct recruits in sanctioned cadre strength and further confirmation in the service as per the Haryana Forest Department (State Service Group B) Rules 1980. He also prayed for a stay on the process of conveying/reviewing of Selection Committee Meeting for considering of names of HFS-II officers for induction into the Indian Forest Service till the proper year wise seniority and confirmation is not assigned as prescribed in the Haryana Forest Department (State Service Group B) Rules 1980.

The Hon'ble Punjab and Haryana High Court passed the orders on 29.9.2014 in the above said CWP No. 20245 of 2014, which is reproduced as under:-

"The grievance of the petitioner is that he is presently working as General Manager, Haryana Forest Development Corporation Limited, Gurgaon being member of Haryana Forest Service. He was directly recruited in October, 2002. In terms of the Haryana Forest Department (State Service Group B) Rules, 1980 (for short, 'the Rules'), in the cadre, there are separate quotas shown in the Rules for direct recruitment and for promotion. Inter-se seniority of the direct recruits and the promotees has not been finalized w.e.f. January, 2003 and in the absence thereof, the direct recruits, like the petitioner, are being prejudiced for further promotion for nomination to Indian Forest Service.

Considering the aforesaid submissions made by learned counsel for the petitioner, in my opinion, the present petition can be disposed of at this stage with a direction to respondent No. 1 to finalise the seniority of the members of Haryana Forest Service Class-II within a period of six months from the date of receipt of a copy of the order. Ordered accordingly."

The Secretary, UPSC, New Delhi vide letter dated 07.11.2014 also requested that in view of aforesaid directions dated 29.9.2014 passed by Hon'ble High Court in the above said CWP No. 20245 of 2014, the seniority of SFS Officers of Haryana may be finalized and the Order of the Hon'ble High Court may be kept in view while sending the proposal for preparation of the Select Lists for promotion to IFS of Haryana Cadre.

In compliance of said orders dated 29.09.2014 passed by Hon'ble High Court, the Government vide order dated 15.12.2014 constituted a Committee comprised of Shri S.S.Jattan, IFS, Managing Director-cum-Principal Chief Conservator of Forests, Haryana Forest Development Corporation, Shri Rupinder Singh, IFS, Chief Conservator of Forests (Administration), Shri D. K. Sinha, IFS, Conservator of Forests (Social Forestry) and Shri D. Hembram, IFS, Special Secretary to Govt. of Haryana, Forest Department to consider the issue of seniority of HFS Officers. The terms of reference of the Committee was to prepare the seniority list of HFS from 2008 to 2014 keeping in view the cadre strength of HFS officers during relevant period, ratio of Direct and Promotee Officers in the cadre and other relevant factors. The issue raised in CWP No. 20245 of 2014 (O&M) - Subhash Chander Yadav Vs. State of Haryana and

the order of Hon'ble High Court dated 29.09.2014 was also to be kept in view while preparing the seniority list.

Vide letter dated 06.01.2015, the Committee submitted its detailed report along with relevant Annexures, gradation-cum-seniority lists from 2008 to 2014 and procedure adopted in preparing the seniority lists from year 2008 to 2014. The Committee has stated in its report that keeping in view the revised seniority of Forest Rangers issued by PCCF vide his order No. 347 dated 14.12.2004, various orders issued by the Govt. from time to time deciding the seniority of HFS officers, inter-seniority among direct HFS officers sent by HPSC and subject to all court cases pending till date, the seniority of HFS officers as stood on 01.01.2008 to 01.01.2014 may be notified. Before publishing seniority list of different years, the promotion orders issued by the Govt., the date of appointment to HFS, the date of regular appointment etc. need to be amended accordingly as recommended in the seniority list prepared by the Committee.

After consideration of the recommendations of the aforesaid Committee, a tentative revised seniority list of HFS (Group-B) officers for the year 2008 and tentative seniority lists of direct and promotee HFS (Group-B) officers alongwith the date of appointment, the proposed regularization dates of services of adhoc promotee HFS officers from the year 2009 to 2014 were circulated by PCCF, Haryana vide his letter dated 19.01.2015 to all working as well as retired HFS officers for inviting their objections.

Objections were received from 22 HFS officers and same was referred to the Committee constituted by the Govt. vide Memo No. 5208-Ft.-3-2015/1989 dated 10.02.2015 for finalizing the seniority list of HFS officers. An opportunity of personal hearing was also given to HFS officers on 12.02.2015. During the personal hearing, the Committee was also directed to work out seniority list from year 2000 to 2007. The Committee analysed the written objection submitted by 22 HFS Officers and also interacted with them, during which the Committee discussed the complete gradation cum seniority list from year 2000 to 2014 with the HFS Officers. The Committee submitted its recommendations on the written objection submitted by 22 HFS Officers vide letter No. 3541 dated 19.02.2015. The committee submitted the revised Gradation cum Seniority List from year 2000 to 2014 vide letter No. 3623 dated 24.02.2015.

After hearing the HFS officers and examining the reports of the committee, the Govt. is of the view that there were discrepancies in calculating the total number of posts available in HFS cadre in different years due to creation and abolition of posts and ratio of these among direct and promote officers as per the Haryana Forest Department (State Service Group-B) Rules, 1980. The committee has worked out the cadre strength of HFS in different years whenever the posts were created or abolished by the Government. The objections of the direct recruit HFS officers that the posts created by the state government in the HFS scale cannot be counted for determination of HFS post under Rule 3 of Haryana Forest

Department(State Service Group-B) Rules, 1980 because the same has not been included in the Appendix-A by the Government is not accepted because according to the proviso to the Rule 3 of the Haryana Forest Department(State Service Group-B) Rules, 1980, it is inherent right of Government to make additions to or reduction in the number of such posts or to create new posts with different designation and scales of pay either permanently or temporarily. Due to administrative reasons after creating or abolishing posts in the HFS cadre, the changes in the cadre strength could not be made by amending the Appendix A of the Haryana Forest Department(State Service Group-B) Rules, 1980. This however, is a procedural irregularity as the department has been treating these posts in the HFS cadre. This omission is regularized now by this order. Accordingly the total number of posts available in HFS cadre in different years due to creation or abolition of posts and ratio of these among direct and promote officers under the Haryana Forest Service (State Service Group-B) Rules, 1980 are held to be as under:-

The Committee has also recommended the date of appointment and regularization of promotee HFS officers keeping in view the availability of posts in the HFS cadre against promotion quota. The Govt. holds the date of appointment and regularization of HFS officers recommended by the committee to be correct.

Therefore, keeping in view all the aspects under Rule 13 of the Haryana Forest Department(State Service Group-B) Rules, 1980 and report of the Committee, the earlier regularization orders dated 18.09.2003 issued vide Endst. No.1815-Ft-3-2003/21835 dated 24.09.2003, the order dated 25.06.2007 issued vide Endst. No. 4314-Ft-3-2007/10799 dated 26.06.2007 and order dated 16.01.2008 issued vide Endst. No. 463-Ft-2-2008/970 dated 17.01.2008 are hereby partially modified and the Governor of Haryana is pleased to regularize the following HFS Class-II officers with effect from the date shown against each in column No. 4 of the seniority lists given below and further pleased to fix the seniority of HFS Class-II officers as under:-
