- 2. The Headquarter of the Board will be at Chandigarh.
- The Board will function as per rules laid down in Wildlife (Protection) Act, 1972 and Wildlife (Protection)
 Haryana Rules, 1974.
- 4. Fifty percent members of whom at least two are non-official members, shall from quorum for a meeting.
- The Board will meet half yearly under the Chairmanship of the Chief Minister and in his absence one of the Minister Incharge/Secretary Forests (Wildlife) will preside over it.
- The term of the board will be for three years but the Government may by express order reconstitute the board at an early date.
- The traveling allowance admissible to the non-official members will be as per latest instructions of the Political Department.
 - (a) The other conditions laid down in the Punjab T.A. Rules for Government employees will also apply to journey performed by non-official members except where otherwise provided.
 - (b) The traveling allowance for attending the meeting of the Board should be allowed to the members from their permanent places of residence to the place of meeting. If however a member attends a meeting from a place other than the place of his permanent residence T.A. should be allowed to him either from the place of his residence or from where he attends the meeting, whichever is less.
 - (c) The traveling allowance and D.A. will be admissible to the non-official members on the production of a certificate to the effect that no T.A. in respect of journey or D.A. for the period mentioned in the bill has been or will be claimed by him/her from any other official source.
- 8. The T A/DA admissible to the official member will be born by their respective Departments.
- 9. The expenditure on account of traveling allowance etc. or the non-official members of the Board will be met out from saving of sanction budget of the Department under the Head "2406-Forestry and Wildlife."
- 0. The Member Secretary of the Board shall be the controlling authority in respect of payment of allowances.
