Section 1: Vision, Mission, Objectives and Functions

Vision

Conservation and development of Forests and Tree Cover in the state through scientific management on sustainable basis, for present and future generations in perpetuity.

Mission

To plan, execute, coordinate and monitor the implementation of Forestry and Wildlife programmes to ensure ecological security, conservation of flora & fauna and environmental balance by sustainable management of forests and enhancing the Forest and Tree Cover as envisaged in State Forest Policy through peoples participation for meeting people needs and better realization of ecological goods and services.

Objectives

- 1 Protection, Conservation, development and sustainable management of Forests, Wildlife and Protected Areas through application of scientific management interventions, productivity enhancement and habitat improvement techniques.
- 2 To increase the Forest and Tree Cover to 20% in a phased manner in the state as envisaged in the State Forest Policy.
- 3 Expansion of Tree Cover outside forests by adopting Agro / Farm Forestry, Urban Forestry, Publicity and Extension.
- 4 To elicit people's participation on the principle of Joint Forest Management and involvement of other line departments to make forestry and wildlife programmes a success.
- 5 Awareness generation among the general public to sensitize them towards the need of conservation and protection of forests and wildlife.
- 6 Carry out need based research in new areas of forest and wildlife sector and application of Information Technology in scientific management and development of forests.
- 7 Regulation and monitoring of FCA cases and implementation of Compensatory Afforestation programmes.

Functions

- 1 Regeneration of Govt. Forest Lands including degraded forests.
- 2 Increasing Tree Cover outside forests through Farm Forestry, Agro Forestry, Urban Woodlots, Roadside / Canal side plantations etc.
- 3 Reclamation of waterlogged, salt affected soils and other wastelands through appropriate plantation models.
- 4 Implementation of provisions of related legislations on Forests and Wildlife.
- 5 Protection of Govt. Forests.
- 6 Enhancement of forest productivity through application of scientific management interventions, tree and seed improvement technology and need based research in new areas.

- 7 Promotion of Eco- Tourism for awareness generation and provide livelihood opportunities to the local community.
- 8 Timber extraction from the forest areas as per working plan prescriptions and conversion of timber to fulfill the needs of local people.

- 10 Timely disposal of FCA cases.

- 12 Human Resource Development and capacity building of all stakeholders.
- 13 Application of MIS and GIS technologies to develop Decision Support Systems for forestry and wildlife management.
- 14 Transfer of technology to the farmers to adopt agro-forestry models and supply of quality planting materials to the farmers, institutions and individuals at subsidized rates to increase green cover in the state and increasing income to the farmers/ panchayats.
- 15 Scientific management and Habitat development in Protected Areas (P.A.s) and other forest areas including wetlands.
- 16 Public Awareness about importance of Forestry and Wildlife
