MAHARASHTRA ACT No. I OF 2010.

(First published, after having received the assent of the Governor, in the "Maharashtra Government Gazette", on the 7th January 2010).

An Act further to amend the Dr. Babasaheb Ambedkar Technological University Act, 1989 and the Maharashtra Universities Act, 1994.

WHEREAS both Houses of the State Legislature were not in session:

AND WHEREAS the Governor of Maharashtra was satisfied that circumstances existed which rendered it necessary for him to take immediate action further to amendthe Dr. Babasaheb Ambedkar Technological University Act, 1989

Mah. XXII of 1989. and the Maharashtra Universities Act, 1994, for the purposes Mah. hereinafter appearing; and, therefore, promulgated the Dr. Babasaheb Ambedkar Technological University and the 1994. Maharashtra Universities (Amendment) Ordinance, 2009 on the 31st August 2009;

AND WHEREAS it is expedient to replace the said Ordinance by an Act of the State Legislature; it is hereby enacted in the Sixtieth Year of the Republic of India as follows:—

- Short title 1. (1) This Act may be called the Dr. Babasaheb Ambedkar Technological University and the Maharashtra Universities (Amendment) Act, 2009.

Amendment of Mah. XXII

2. In section 12 of the Dr. Babasaheb Ambedkar Mah. of section 12 Technological University Act, 1989, in sub-section (7), for XXII of 1989; the words "until a period of six months" the words "until a 1989. period of twelve months" shall be substituted.

Amendment of Mah.

3. In section 12 of the Maharashtra Universities Act, 1994, Mah. of section 12 in sub-section (7), for the words "a term not exceeding six xxxv XXXV of months" the words "a term not exceeding twelve months" of 1994. shall be substituted.

Repeal of Mah. Ord. XXII of 2009

4. (1) The Dr. Babasaheb Ambedkar Technological Mah. University and the Maharashtra Universities (Amendment) XXII Ordinance, 2009 is hereby repealed. of. 2009.

(2) Notwithstanding such repeal, anything done or any action taken (including any notification or order issued) under the Dr. Babasaheb Ambedkar Technological University Act, Mah. 1989, or, as the case may be, the Maharashtra Universities XXII Act, 1994, as amended by the said Ordinance, shall be deemed 1989. to have been done, taken or issued, as the case may be, under Mah. the corresponding provisions of the relevant Act, as amended XXXV by this Act.
