## Order

No. RB/DB/e-11014(1)(2018)/Allowances RDB/2018/256 :—By order No. GSA/94/DB/907, dated 4th July 1994, the honorarium for the Chairman and sitting fees of the members of the Development Boards were specified in Part –A and Part – B of the Order.

In exercise of the powers conferred by Clause 5 of the Development Boards for Vidarbha, Marathwada and the Rest of Maharashtra Order, 1994, by Order No. GS/DB/2008/339, dated 17th November 2008, the Governor of Maharashtra had made an Order revising, the honorarium of the Chairman, sitting fees of the members and sitting allowances of members of the Special Subject Committees of the Development Boards.

Now, in exercise of the powers conferred by Clause 5, sub-clause (*d*) of the Development Boards for Vidarbha, Marathwada and the Rest of Maharashtra Order, 2011, the Governor of Maharashtra hereby makes the following order revising, the honorarium of the Chairman, sitting fee and sitting allowance of the non-official members of the Development Boards and the Special Subject Committee for attending any meetings of the Development Boards, and reimbursement of expenditure on account of Accommodation and food for non-official members of the Development Boards for the official meetings :—

1. The honorarium of the Chairman of the Development Board will be ₹15,000 per month.

2. For non-official members, the sitting fee and sitting allowance will be ₹1500 per day, for attending the meetings of the Development Board, and

₹ 500 per day, for attending any meetings, of the Special Subject Committee officially assigned to him / her by the Development Board.

3. For non-official members, when they attend the meeting of the Development Board (not the Special Subject Committee), they will be entitled for reimbursement of expenditure on account of accommodation and food charges, for each meeting upto a limit of ₹ 5,500 in Mumbai, and ₹ 3,500 in other cities in Maharashtra, which will be inclusive of food charges upto a limit of ₹ 800.
