1.0 INTRODUCTION:

The National Institute for the Empowerment of Persons with Intellectual Disabilities (Divyangjan), Secunderabad formerly known as National Institute for the Mentally Handicapped is a registered society, established in the year 1984 as an autonomous body under the Department of Empowerment of Persons with Disabilities (Divyangjan), Ministry of Social Justice and Empowerment, Government of India. The institute is an apex body having tripartite functions of training, research and services in the field of Intellectual Disabilities in the country, NIEPID has regional centres at New Delhi/Noida, Navi Mumbai and Kolkata.

The Objectives are:

- Human resource development
- Research and development
- Development models of care and rehabilitation
- Consultancy services to voluntary organizations
- Documentation and dissemination
- Extension and Outreach programmes

For 40 years, the Institute has been making significant advances in building capacities to empower persons with Intellectual Disabilities. Based on the latest developments and recent trends in the field, the Institute strives to organize new programmes and make innovations through research and development, National and International collaborations entered into by the Institute in its various activities reflect the global characteristics of the organization. The activities of NIEPID are planned in accordance with the mandates of United National Policy promulgated for the Persons with Disabilities (UNCRPD), the Legislative Acts and the National Policy promulgated for the persons with Disabilities, NIEPID strives to be an Institute of excellence focusing on high standards in every aspect of its functioning to bring equality and dignity in the lives of persons with Intellectual Disabilities which is endorsed by ISO 9001-2015 certification..

1.1 GENERAL OBJECTIVES OF THE COURSE:

An Indian Sign Language Interpreter is responsible for helping deaf individuals understand what is being said in a variety of situations. An Indian Sign Language Interpreter must understand the subject matter of discourse so he or she can accurately translate what is being spoken into Indian Sign Language. An Indian sign language interpreter may be present to translate during an office meeting, in a courtroom, or at a political speech. Interpreters may also be used in one-on-one situations to help two parties communicate with each other. Indian Sign Language interpreters might use technology to provide services from a remote location.

Carrying out the interpreter's main duties requires listening, sign language and communication skills. An Indian Sign Language Interpreter may also have to do research if he or she is working in a situation involving highly technical information or complex information to gain an understanding of what will be interpreted. A good memory is also important since an interpreter will need to remember what has been said in order to sign it.

2.0 KNOWLEDGE RELATED OBJECTIVES:

- 1. The main objective of the programme is to train Indian Sign Language interpreters to provide communication access to Deaf and Hard of Hearing people in various settings in real life.
- 2. Explore Deaf culture and society and study the structure and use of Indian Sign Language (ISL).
- 3. Increasing understanding of the principle, ethics relating to ISL interpretation in the field.

3.0 JOB OPPORTUNITIES: On completion of the course, trainees can work as

- 1. Sign Language Interpreters in different government and non governments.
- 2. Instructors for children with speech and hearing problems.
- 3. Instructors for sign language Interpreters.

4.0 Eligibility for ADMISSION

For admission: A Candidate should have:

- a) Senior Secondary (10+2) or equivalent with minimum 50% marks
- b) Functional hands
- c) Fluency in at least one language

d) Hearing in the normal range

The reservation and relaxation for SC/ST/OBC/PWD and other categories shall be as per the rules of the Central Government/ State Government, whichever is applicable.

5.0 SELECTION:

Application for admission will be screened and short listed on the basis of three candidates per seat by the committee specially constituted for the purpose. Merit list will be prepared based on the marks in essential qualification. Admissions will be taken following the reservation and seat allotment criteria based on central government norms. TA/DA will **not** be paid by the institute for attending the interview. No candidate is allowed to change the course of study once admitted and if he/she is still desirous to join any course within the institute, the fee/deposits remitted to the institute shall be forfeited.

6.0 JOINING AND SUBMISSION OF CERTIFICATES:

Selected candidates should join the course by the stipulated date. At the time of joining the course, the selected candidates will have to produce. (a) Undertaking to the effect that the admitted candidates will not discontinue the course and (b) Medical certificate of fitness.

7.0 NUMBER OF SEATS:

As per RCI approval 20 seats only.

8.0 DURATION: The duration of the course will be 220 days consisting of 1200 hours each year thus having a total of 2400 hours for theory and practicum. (Two academic Year).

9.0 MEDIUM OF INSTRUCTION:

The medium of instruction will be Indian Sign Language and English/Hindi. Regional center instructors if fluent in regional language may use that regional language along with Indian Sign Language.

10.0 ATTENDANCE:

Minimum 75% attendance in theory and practical is required per RCI NBER guidelines. Working days are Monday to Friday. 10% attendance may be considered for illness with a proper medical certificate. All practical work and assignments must be completed and certified by faculty before examination. The competent authority will make the final decision on exam eligibility.

Students must make up attendance shortages before final exams; the institute won't arrange extra classes. Applications from students with insufficient attendance won't receive hall tickets for exams.

The institute may cancel admission for habitual absenteeism, poor attendance, lack of academic progress, or disinterest in the course. Examination procedures will follow Rehabilitation Council of India guidelines. Those who are having 75% attendance is only eligible for scholarships.

11.0 AWARD OF DIPLOMA:

Based on the performance during the course and on the annual examination, the successful candidates will be awarded D.I.S.L.I. Minimum marks of passing examinations will be 40% in each theory paper (internal and external separately) and practical paper will be 50% (internal and external separately). Candidates scoring 75% and above will be awarded the Diploma with Distinction.

12.0 FEES & OTHER DIPOSITS: Fees for per annum are as follows:

Tuition fees are waived for students with disabilities holding UDID Cards or Disability Certificates enrolled on the UDID portal, regardless of disability percentage. Full fee waiver is granted for parents of persons with disabilities (PWD). Tuition, examination fees, and other expenses may be revised by NIEPID and RCI. Deposits are refundable only upon successful completion of the course. Additional statutory fees required by the University/Board will be collected later. Candidates admitted to the course cannot withdraw; if they do, all fees and deposits will be forfeited.

• Original certificates deposited will not be released during the course and students are advised to keep sufficient number of photo copies before submission of original certificates to office at the time of admission. All students should submit the Transfer certificate at the time of admission.

13.0 HOSTEL ACCOMODATION:

Shared hostel accommodation to outstation candidates will be provided on nominal charge at NIEPID, Secunderabad subject to availability on first-come-first-served basis. The trainees will have to bear the expenses on food by joining a student's run mess which is not included in the Hostel fee.

14.0 DISCIPLINE:

The candidates admitted should abide with discipline within the prescribed administrative regulations and also avail the hostel accommodation as provided. The candidates are expected to maintain decorum, decency and discipline throughout their pursuance of the course with the staff, faculty, co-students and other supporting staff. The hostellers should follow the prescribed rules and regulations. Use of cell phones for personal reasons/entertainment during working hours is strictly prohibited. Any infringement of violence shall result in removal of the student from the hostel for the period as decided by the management of the institute.
