3. The tender is required to be submitted through GeM online under two bid system
4. The successful bidder shall have to deposit a performance security deposit @ **5%** of the total value of the order in the form of Demand Draft/Bank Guarantee which should be valid for over and above two months of completion of work/supply or the warranty period. The following documents will be checked for technical scrutiny :
 - a) Shall submit three (03 nos.) similar work order of **Rs. 12,000/-** each or two (02 nos) work order of **Rs. 15,000/-** each or One work order of **Rs. 25,000/-** from Central/State government organization / PSUs in the preceding 3 years from different organizations executed in the last 03 years
 - b) Shall have firm/shops and establishment registration certificate (Attach copies).
 - c) Stamp & Signature of the agency on all the pages.
 - d) Acceptance certificate of technical & financial bid as per Annexure-A & B.
 - e) GST/VAT/CST Certificate of the firm to be attached
 - f) PAN details to be attached
 - g) The bidder should submit Compliance report of technical specification as per Annexure-I
 - h) The bidder must submit a self certificate that it has not been blacklisted by any Govt./Other Agency since its inception
