- Shall submit three (03 nos.) similar work order of **Rs. 25,000/-** each or two (02 nos) work order of **Rs. 30,000/-** each or One work order of **Rs. 50,000/-** from Central/State government organization / PSUs in the preceding 3 years from different organizations executed in the last 03 years
 - Shall have firm/shops and establishment registration certificate (Attach copies).
 - Stamp & Signature of the agency on all the pages.
