GENERAL TERMS & CONDITIONS:

- The applicant must be a citizen of India.
- The registration for walk-in-interviews/screening will be held from 9.00AM to 11.30 AM on 30.06.2026. Candidates who will be attending after the prescribed will not be entertained.
- All applicants must fulfill the essential qualifications for the posts and other conditions stipulated in the notification as on the last date for receipt of applications.
- The filled in applications, in the prescribed format, along with the self-attested copies of certificates in support of educational qualifications, experience, disability etc
- Mere possessing the EQ will not entail any candidate a right to be considered eligible for the post. The final list of candidates called for interview/written test is based on the short-listing of candidates by a duly constituted Screening Committee. Only short-listed candidates will be communicated and no interim correspondence will be entertained.
- The contractual posts, the maximum age limit will be 56 years (age shall be reckoned as on closing date of receipt of application).
- No TA/DA will be paid for attending the interview.
- All correspondence from the Institute to the candidate(s) shall be made exclusively by way of email / mobile in the column provided by the candidate(s). Therefore, candidate(s) are requested to retain the email-ID and check it regularly.
- The number of positions may increase/decrease as per the requirement.

- (j) Candidates willing to work may attend the walk-in-interview duly completing the prescribed application format which is available on the Institute's website along with documents supporting educational qualification, experience etc and amount of Rs.200/- towards application fee to be paid at the time of walk in interview through online (QR code will be provided at the time of interview). No fee required in case of SC/ST/PH/Women candidates.
- (k) The term of appointment shall ordinarily be for an initial period of 1 year and extendable on yearly basis (for maximum of 3 years or completion of project whichever is earlier) subject to satisfactory performance of the staff.
- (l) The Institute reserves right to accept or reject the application without assigning any reasons. Canvassing in any manner will disqualify from the selection process.
- (m) Any alterations/modifications to the notification/terms & conditions will be issued by way of addendum notification on the Institute's website only.
