1.	Assistant Professor in Special Education	Essential: 1. Masters in Social Sciences with M.Ed in Special Education (MR)/M.Ed with DSE (MR) or equivalent qualifications and Ph.D with dissertation topic in the field of education of children with mental retardation. 2. Five years experience in teaching professionals or personnel/research in the field of Special Education (MR).
2.	Lecturer in Special Education	Essential: M.Ed SE (MR) with Post Graduation and 3 yrs of teaching/research with clinical experience

General Conditions for empanelment of guest faculty:

- **The registration** for walk-in-interviews/screening **will be held from 9.00 AM to 11.30 AM** at NIEPID Secunderabad. Candidates who will be attending after the prescribed will not be entertained.
- The candidates should attend the walk in interviews as per the posts mentioned against each centres only.
- Candidates applying for the above positions should have minimum 55% or equivalent pass percentage in the qualifying examination of the concerned disciplines. The experience should be post-qualification from the date of acquiring the qualifying professional degrees.
- Though guest faculties are engaged on session wise basis, most of them are required during complete office hours on all working days, i.e. from 9.00 am to 5.30 pm. totaling to 4sessionsinaworking day, which means that the faculties / staff are required fulltime.
- Candidates willing to work may attend the walk-in-interview duly completing the prescribed application format which is available on the Institute's website along with documents supporting educational qualification, experience etc. and **amount of Rs.200/- towards** application fee to be paid at the time of walk in interview **through online** (QR code will be provided at the time of interview). No fee required in case of SC/ST/PH/Women candidates.
- The candidates will be kept in the empanelment list based on the selection and will be engaged as per the requirement and need based only. Mere attending the interview /screening will not entail a candidate to be engaged as Guest Faculty/staff.
- Qualifications / experience may be relaxed in case of deserving / exceptional candidates for guest faculty positions only.
- No TA/DA will be paid for attending the interview.
- The period of engagement will be 6months, extendable for further 6months or till the completion of the course / program.
- All correspondence from the Institute to the candidate(s) shall be made exclusively by way of email / mobile in the column provided by the candidate(s). Therefore, candidate(s) are requested to retain the email-ID and check it regularly.
- The candidates will be empanelled based on the performance in the interview.
- All the candidates applying for the above positions should have valid RCI/MCI registration.
