WHEREAS, biennial elections have to be held for the purpose of filling the above vacancies so arising;

NOW, THEREFORE, in pursuance of Section 12 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby recommends the 20th October, 2020 (Tuesday), as the date on which the President of India may, by notification published in the Gazette of India on the said date, be pleased to call upon the elected members of each of the said Legislative Assemblies of the States, specified in column (1) of the TABLE below, to elect the number of member(s), specified against the State in column (2) of the said TABLE, to the Council of States, for the purpose of filling the above vacancies, in accordance with the provisions of the said Act and of the rules and orders made thereunder :-

यतः, सारणी के स्तम्भ (2) में तत्स्थानी प्रविष्टियों में दिखाई गई संख्या के अनुसार उक्त सारणी के स्तम्भ (1) में विनिर्दिष्ट राज्यों की विधान सभाओं के निर्वाचित सदस्यों द्वारा निर्वाचित राज्य सभा के 11 सदस्यों के स्थान उनकी पदावधि समाप्त होने पर स्तम्भ (3) में तत्स्थानी प्रविष्टियों में वर्णित तारीख पर उन सदस्यों के सेवानिवृत्त होने के कारण रिक्त होने वाले हैं; और

यतः, इस प्रकार उत्पन्न हुई उक्त रिक्तियों को भरने के प्रयोजन से द्विवार्षिक निर्वाचनों को कराया जाना है;
