Sir,

The Election Commission has appointed me as the Returning Officer for the Vice-Presidential Election, 2025. The Notification regarding the appointment will be published in a Gazette of India Extraordinary dated the 7th of August, 2025.

2. I am to enclose an advance copy of Public Notice (in English and Hindi) under Rule 3 of the Presidential and Vice-Presidential Elections Rules, 1974, relating to the election to the Office of Vice-President of India which is being published in an Extra-ordinary issue of the Gazette of India dated the 7th of August, 2025. You are requested to kindly take immediate steps to re-publish the public notice on the same day i.e. the 7th of August, 2025 in an Extra-ordinary issue of the Official Gazette of the State Government/Union Territory Administration in the language or languages in which Statutory notifications issued by the State Government/Administration are published in such Gazette. This notice should be published and publicized immediately following the Election Commission's Notification Nos.480/Programme/2025& 480/P.O.P/2025 dated the 7th of August, 2025, regarding the programme, place and hours of polling of the Vice-Presidential Election sent to the Chief Electoral Officer of your

State/Administration along with the Commission's letter No. 481/ECI/LET/FUNC/V.P.E/BIEN/2025 dated the 4th of August, 2025.

3. As per the direction of the Election Commission of India, you are also requested to give wide publicity of the election programme by Radio and Doordarshan, announcement from the stations of All India Radio/Doordarshan Centres at New Delhi, at the State Capitals and at other places (if any) throughout the country and through other official media.

4. Two copies of the Gazette of your State/Administration in which the Public Notice is re-published may please be sent to the undersigned as soon as the same is printed in the Gazette.

WHEREAS a notification under sub-section (1) of Section 4 of the Presidential and Vice-Presidential Elections Act, 1952, for the holding of an election to fill the Office of Vice-President of India has been issued by the Election Commission, I, P.C. MODY, the Returning Officer for such election, do hereby give notice that—

(i) nomination papers may be delivered by a candidate or any one of his proposers or seconders to the undersigned at his office in Room No. RS-28, First Floor, Parliament House, New Delhi, or if he is unavoidably absent, to the Assistant Returning Officers, Ms. Garima Jain, Joint Secretary/Shri Vijay Kumar, Director, Rajya Sabha Secretariat at the said office between 11 a.m. and 3 p.m. on any day (other than a public holiday) not later than Thursday, the 21st August, 2025;

(ii) each nomination paper shall be accompanied by a certified copy of the entry relating to the candidate in the electoral roll for the Parliamentary constituency in which the candidate is registered as an elector;

(iii) every candidate shall deposit or cause to be deposited a sum of Rupees Fifteen Thousand only. This amount may be deposited in cash with the Returning Officer at the time of presentation of the nomination paper or deposited earlier in the Reserve Bank of India or in a Government Treasury and in the latter case a receipt showing that the said deposit of the sum has been so made is required to be enclosed with the nomination paper;


(iv) forms of nomination papers may be obtained from the above said office at the time aforesaid;

(v) the nomination papers, other than those rejected under sub-section (4) of Section 5B of the Act, will be taken up for scrutiny at the said office in Room No. F-100, Sangoshthi-2, First Floor, Parliament House, New Delhi, on Friday, the 22nd August, 2025 at 11 a.m.;

(vi) the notice of withdrawal of candidatures may be delivered by a candidate, or any one of his proposers or seconders who has been authorised in this behalf in writing by the candidate, to the undersigned at the place specified in paragraph (i) above before three o'clock in the afternoon of Monday, the 25th August, 2025;

(vii) in the event of the election being contested, the poll will be taken on Tuesday, the 9th September, 2025 between the hours of 10 a.m. and 5 p.m. at the place of polling fixed under the rules.

यतः, भारत के उपराष्ट्रपति पद भरने के लिए निर्वाचन करने के लिए, निर्वाचन आयोग द्वारा, राष्ट्रपतीय और उपराष्ट्रपतीय निर्वाचन अधिनियम, 1952 की धारा 4 की उपधारा (1) के अधीन अधिसूचना जारी की गई है। ऐसे निर्वाचन के लिए निर्वाचन अधिकारी, मैं, पी.सी. मोदी एतद्द्वारा सूचना देता हूँ कि—

(i) अभ्यर्थी या उसके किसी प्रस्थापकों या समर्थकों में से किसी एक द्वारा नामनिर्देशन पत्र निम्नहस्ताक्षरकर्ता को कमरा संख्या आरएस 28, प्रथम तल, संसद भवन, नई दिल्ली स्थित उसके कार्यालय में या यदि वह अपरिवर्जनीय रूप से अनुपस्थित हो, तो सहायक निर्वाचन अधिकारी, सुश्री गरिमा जैन, संयुक्त सचिव/श्री विजय कुमार, निदेशक, राज्य सभा सचिवालय को उक्त कार्यालय में किसी भी दिन (सार्वजनिक अवकाश-दिन से भिन्न) मध्याह्न पूर्व 11 बजे से मध्याह्न पश्चात् 3 बजे के बीच, बृहस्पतिवार, 21 अगस्त, 2025 तक परिदत्त किए जा सकेंगे;

(ii) प्रत्येक नामनिर्देशन पत्र के साथ उस संसदीय निर्वाचन-क्षेत्र की निर्वाचक नामावली में अभ्यर्थी से संबद्ध प्रविष्टि की एक प्रमाणित प्रति लगाई जाएगी जिसमें अभ्यर्थी निर्वाचक के रूप में रजिस्ट्रीकृत है;

(iii) प्रत्येक अभ्यर्थी केवल पंद्रह हजार रुपये की राशि जमा करेगा या जमा करवाएगा। यह रकम नामनिर्देशन पत्र प्रस्तुत करते समय निर्वाचन अधिकारी के पास नकद जमा की जा सकेगी या भारतीय रिज़र्व बैंक या किसी सरकारी खजाने में इससे पहले जमा की जा सकेगी और पश्चातकथित दशा में ऐसी रसीद का,

जिसमें यह दर्शित किया हो कि उक्त राशि जमा कर दी गई है, नामनिर्देशन पत्र के साथ लगाया जाना आवश्यक होगा;


(iv) नामनिर्देशन पत्रों के प्ररूप पूर्वोक्त कार्यालय से पूर्वोक्त समय पर प्राप्त किए जा सकेंगे;

(v) अधिनियम की धारा 5ख की उपधारा (4) के अधीन नामंजूर किए गए नामनिर्देशन पत्रों से भिन्न, नामनिर्देशन पत्रों की संवीक्षा उक्त कार्यालय, कमरा संख्या एफ—100, संगोष्ठी—2, प्रथम तल, संसद भवन, नई दिल्ली में शुक्रवार, 22 अगस्त, 2025 में शुक्रवार, 22 अगस्त, 2025 को मध्याह्न पूर्व 11 बजे की जाएगी;

(vi) अभ्यर्थिता वापस लेने की सूचना अभ्यर्थी, या उसके प्रस्थापकों या समर्थकों में से किसी एक द्वारा, जो अभ्यर्थी द्वारा लिखित रूप से इस निमित्त प्राधिकृत किया गया हो, निम्नहस्ताक्षरकर्ता को उपरोक्त पैरा (i) में विनिर्दिष्ट स्थान में सोमवार, 25 अगस्त, 2025 को अपराह्न तीन बजे से पहले परिदत्त की जा सकेगी;

(vii) निर्वाचन लड़े जाने की दशा में, मतदान इन नियमों के अधीन नियत किए गए मतदान के स्थान में मंगलवार, 9 सितंबर, 2025 को मध्याह्न पूर्व 10 बजे और मध्याह्न पश्चात् 5 बजे के बीच होगा।
