This RFP is being issued by the Cooperative Department Uttarakhand for the selection of qualified Event Management Agency(s) for organizing "Sahkarita Mela 2025" in all thirteen districts of Uttarakhand. The Cooperative Department reserves the right to cancel this RFP at any time without prior notice and without assigning any reasons. The Cooperative Department is not bound to accept any proposal and reserves the right to reject any or all proposals received without incurring any liability to the affected applicant(s).

These Melas aim to:

- Promote local artisans, FPOs, SHGs, and cooperatives
- Encourage rural tourism and cultural exchange
- Provide a platform for marketing and showcasing indigenous goods

2. Objective

To empanel competent event management agencies or organizations for conceptualizing, planning, and executing district-wise Melas in Uttarakhand

Tentative Mela Clusters/Phases (Subject to Change):

* **Cluster 1** (Garhwal Region): Dehradun, Haridwar, Pauri Garhwal, Tehri Garhwal, Uttarkashi, Rudraprayag, Chamoli.

* **Cluster 2** (Kumaon Region): Nainital, Almora, Pithoragarh, Champawat, Bageshwar, Udham Singh Nagar.

Agencies may bid for a specific cluster or for all thirteen districts. However, preference may be given to agencies demonstrating the capacity to manage events across multiple districts or the entire state.

4. Scope of Work

The selected agency will be responsible for:

5. Eligibility Criteria

- Legal Status: The Bidder must be a legally registered entity in India (e.g., Company registered under Companies Act 1956/2013, Partnership Firm registered under Partnership Act 1932, LLP registered under LLP Act 2008).
- * Experience in organizing multi-location events, particularly in hilly or rural terrains, will be highly preferred.
- The Agency/Service Provider should have organized at least 5 events in past 02 year wherein 2 events should be a Mela's/Exhibition with at least 25 stalls. The Agency/Service Provider has to submit a list of events organized over the last 24 months as supporting document
- The Agency/Service Provider should have turnover of at least Rs 50 lakh from organizing events over the last 12 months. Supporting documents to be submitted along with the bid.
- Successfully organized at least 3 major public events (over 5,000 footfall)

- Must demonstrate ability to mobilize sponsorships or other funding sources
- Local presence in Uttarakhand preferred (Address of Uttarakhand)
No Blacklisting: The Bidder or any of its directors/partners should not have been blacklisted by any Central/State Government Department, Public Sector Undertaking (PSU), or autonomous body in India. A sworn affidavit to this effect on a non-judicial stamp paper of appropriate value must be submitted.

6. Proposal Submission

The interested parties must submit a proposal containing:

- Concept plan and financial model (cost-recovery strategy)
- Past experience and client references
- Timeline and event calendar
- Team profile and local partnership strategy

7. Process of Selection

The Budget for each mela/Exhibition (event) is capped by own source

Maximum footfall over the period of 3 days should be 1000 person.

The eligibility condition given at clause 5 shall have 60% weightage and shall be evaluated as under:
