#### Terms and Conditions:

- The selected agency shall pay a yearly revenue of minimum One Lakh INR as advertisement revenue to PMDA, Panchkula.
- The ownership of the Roundabouts and their land shall remains with PMDA, 2. Panchkula. The agency will have no rights over the structures erected.
- Any construction proposed by the agency must receive written approval from 3. PMDA, Panchkula. Structural work, additions, alterations and painting etc. must be approved in writing before implementation.
- All shades of painting, distempering or white washing must be pre-approved by 4. PMDA, Panchkula.
- PMDA, Panchkula reserves the rights to resume control of construction/ 5. maintenance without providing reasons. The decision will be communicated in writing and considered final.
- The agency may display its name on a board not exceeding 50cm X 50cm at the 6. Roundabout. The content and placement of this plate must be approved by PMDA, Panchkula. No other signage or hoarding will be permitted.
- PMDA, Panchkula will oversee and have intervention rights in the construction and 7. maintenance of the roundabouts.

- 8. The agreement will be valid for **One Year** from the date of issue of work order, with the possibility of a One year extension if maintenance standards remain satisfactory.
- 9. The agency will be responsible to strictly follow the guidelines of road safety committee.
- 10. Decoration on the festival, Independence day, Republic Day and any State function by lighting etc.
- 11. The agency will be responsible for functioning of fountain, electrical equipments etc. exited on the Roundabouts and will be maintain them properly time to time.

# Proposed process of allotment of Roundabouts to various agencies:

It is proposed that applications shall be invited by giving an advertisement in three leading newspapers (Two Hindi and One English) for allotment of all above Roundabouts of Panchkula Urban Estate and Mansa Devi Complex. After receipt of applications interview will be conducted by a Committee headed by the ACEO, PMDA, and other members will be the Expert, Infra Engineering, PMDA, Advisor, Urban Environment, PMDA, the Executive Engineer(Hor.), PMDA, Panchkula.

Allotment shall be made on the recommendations of the above Committee to the eligible applicants after the approval of w/CEO, PMDA, Panchkula on the above terms and conditions.

If multiple entries received from any company/NGO, then decision for allotment of roundabout will be taken by the above Committee.
