## Details of Central Verges, Berms and Green Belts of PMDA, Panchkula

## Terms and Conditions for maintenance of Central Verges, Berms and Green Belts

- The selected agency shall pay an amount of Rs. 50,000/- (Fifty thousand) per annum on account of advertisement fee to the PMDA, Panchkula. The allotted agency shall deposit the fee within seven working days from the date of issue of allotment letter.
- 2. The ownership of Green Belt, Berms and/ or Central Verge shall remain with PMDA Panchkula. The agency will not use these properties for any purpose except advertisement their brand value and no sub-letting will be allowed.
- 3. Merely by maintaining a specified Green Belt, Berm and/or Central Verge for a specified period will not confer upon the agency any right what so ever over this Green Belt, Berm and/or Central Verge. The agency will ensure that the property shall remain free from all type of encumbrances.
- 4. The PMDA reserves the rights to resume control of maintenance of Green Belt, Berm and/or Central Verge without providing reasons. The decision of PMDA in this regard will be final.
- 5. The agency may display its brand name on a board not exceeding a size of 75cm x 50cm at the Green Belt, Berm and/or Central Verge. In the Central Verge, the display board shall be erected parallel to the road. The content and placement of this advertising plate/board must be approved by PMDA. No other signage or hoarding will be permitted. The spacing between two signages/boards should not be less than 100 metres.
- 6. The maintenance of Green Belt, Berm and/or Central Verge will be done by the agency under the advice/suggestions of an officer/official of PMDA. PMDA, Panchkula will oversee and have intervention rights in the maintenance of Green Belt, Berm and/or Central Verge.
- 7. The maintenance period of the specified Green Belt, Berm and/or Central Verge will be valid for one year from date of issue of allotment letter. The maintenance period may be extended for additional one year provided the maintenance standards remain satisfactory.
- 8. The agency will be responsible to follow the guidelines of road safety committee scrupulously in true letter and spirit.
  - 9. The agency will be responsible for the functioning and maintenance of electric equipments installed on the Green Belt, Berm and/or Central Verge, if any.
  - 10. In case of Central Verge, the agency will maintain the complete ROW i.e. total width of road including footpath and side berms. The agency will ensure smooth cutting of hedges in Central Verge, cleaning of all kind kind of vegetation and side drains.

## Proposed process of allotment of Central Verges and Green Belts to various agencies:

Applications shall be invited by giving an advertisement in three leading newspapers (Two Hindi and One English) for allotment of all above Central Verges and Green Belts. After receipt of applications interview will be conducted by a Committee. Committee may be constituted under the Chairmanship of W/ACEO, PMDA, for conducting the interviews of the applicants and other members are Expert, IE, PMDA, Advisor, Urban Environment, PMDA, Chief Engineer-I, PMDA, Joint CEO, PMDA and Executive Engineer(Hort.), PMDA, Panchkula. Allotment shall be made on the recommendations of the above Committee to the eligible applicants after the approval of W/CEO, PMDA, Panchkula on the following terms and conditions.
