ORDER

This order relates to the admission of the Petition for approval of Business Plan for the Control Period FY 2025-26 to FY 2027-28 filed by Power Transmission Corporation of Uttarakhand Limited (hereinafter referred to as "Petitioner" or "PTCUL") on 27.11.2024.

2. The Petition filed by PTCUL had certain infirmities/deficiencies which were conveyed to PTCUL vide Commission's letter dated 12.12.2024 asking it to rectify the said infirmities so that the Petition could be admitted. PTCUL vide its letter dated 23.12.2024 has removed critical deficiencies.
3. Based on the Business Plan Petition filed by Petitioner, the Commission decides to admit the Petition provisionally for further processing subject to the condition that PTCUL shall furnish any further information/clarifications as deemed necessary by

the Commission during the processing of the Petition and provides such information and clarifications to the satisfaction of the Commission within the time frame as may be stipulated by the Commission failing which the Commission may proceed to dispose off the matter as it deems fit based on the information available with it.

4. The Commission further directs the Petitioner to publish a public notice within 3 days from the date of this Order detailing the salient features and facts of the Business Plan Petition & proposal filed by it in the format given at Annexure-1 in at least two daily newspapers (one Hindi and one English) widely circulated in the area of its operation both in Hindi and English languages for comments by all stakeholders and public at large. The Petitioner is also directed to place the Petition on its website and its headquarters/other offices for inspection or making relevant extracts available to the public.
