This order relates to the Petition on Annual Revenue Requirement and Tariff Petition for FY 2011-12 filed by Uttarakhand Jal Vidyut Nigam Limited (UJVNL) for its 10 main generating stations, hereinafter referred to as the Petitioner.

2. The Petition filed by UJVNL had certain infirmities/deficiencies which were intimated to UJVNL vide Commission's letter dated 06/12/2010 and UJVNL was asked to rectify the said infirmities so that the Petition may be admitted by the Commission. UJVNL

vide its letter dated 09/12/2010 submitted the information sought by the Commission.

- 3. Based on the submissions dated 09/12/2010 by UJVNL, the Commission provisionally admits the Petition for further processing subject to the condition that UJVNL shall furnish any further information/clarifications as deemed necessary by the Commission during the processing of the Petition and provides such information and clarifications to the satisfaction of the Commission within the time frame as may be stipulated by the Commission failing which the Petition would be treated as deemed returned on the due date for last information sought by the Commission and the Commission would proceed to dispose off the matter as it deems fit based on the information available with it.
- 4. The Commission further directs the Petitioner to publish a public notice within 3 days from the date of this Order detailing the salient information and facts of the ARR petitions & proposals filed by it for FY 2011-12 in the format given at Annexure 1 in at least two daily newspapers (one Hindi and one English) widely circulated in the area of its operation both in Hindi and English languages for comments by all stakeholders and public at large. The Petitioner is also directed to place the Petition on its website and its headquarters/other offices for inspection or making relevant extracts available to the public.

Tariff for its 10 main generating stations for FY 2011-12

Salient Points of the ARR/Tariff Petition

1. Uttarakhand Jal Vidyut Nigam Limited (UJVNL), a Government owned company, has filed the petitions for the determination of generation tariff for the financial year 2011-12 for its 10 main generating stations before the Hon'ble Uttarakhand Electricity Regulatory Commission (Commission). Through the above petitions, UJVNL has also proposed truing up of its expenses for FY 2007-08 for its 9 old generating stations based on the audited balance sheet and for Maneri Bhali-II, truing up for FY 2007-08 to 2010-11 based on the audit of capital cost. The gist of tariff petitions filed by UJVNL for the financial year 2011-12 for its 10 main generating stations, with comparative figures for the financial year 2010-11 are given in the table below:

- 3. UJVNL has proposed a hike of 18.49% for FY 2011-12 on the existing AFC for 2010-11. Further, the impact of truing up would lead to an additional increase of about 38.50% implying a total increase of about 57%. In case the entire claim of UJVNL is accepted by the Commission, an additional hike of 10% in consumer tariff shall be required over and above the hike proposed by UPCL and PTCUL.
- 4.
