Inviting Comments on Petition filed by UJVN Ltd. before the Uttarakhand Electricity Regulatory Commission for review of the UERC's Tariff Order on True-up for FY 2022-23, Annual Performance Review for FY 2023-24 & Annual Fixed Charges for FY 2024-25.

- 1. UJVN Ltd. has filed a review Petition and sought the following reliefs:
 - (i) Correct the arithmetic mistakes in calculation of net cash availability.
 - (ii) Correct/rectify the calculation while computing 'interest from FDR's to be disallowed'.
 - (iii) Consider opening balance of FD's on account of head office, each year from FY2016-17 onwards and any subsequent investment in FD's by the petitioner for computation of interest earned from FD's made out of RoE and exclude such interest from non-tariff income on actual basis.
 - (iv) Accept the allocation of apportionment methodology submitted by the petitioner in a ratio of 95:05 (based on installed capacity) for its 11 LHPs and SHPs including the 120 MW Vyasi project and consider the same methodology for future as well.
 - (v) Allow the RoE @ 15.5%/16.5% towards all additional capitalization till the application of MYT Regulations 2021 i.e., 01.04.23.
