UPCL's Petition for True-Up of FY 2023-24, Annual Performance Review of FY 2024-25, Annual Revenue Requirement for FY 2025-26 to FY 2027-28 along with Tariff Determination for FY 2025-26 and Petition for Business Plan for the Control Period from FY 2025-26 to FY 2027-28.

- 1. The Petitioner is required to submit the division wise details of approvals/sanctions for capital works amounting to Rs. 1 Crore or more and upto Rs. 2.5 Crore, for the works carried out in FY 2023-24 and FY 2024-25 (till December, 2024). The Petitioner is also required to summarize the aforesaid detail in Excel format and submit the same to the Commission with proper referencing.
- The Petitioner is required to submit the division wise details of load growth (consumer category wise) for the FY 2021-22 to FY 2023-24, alongwith details of change in consumer mix during the aforesaid period.
- 3. The Petitioner in its letter dated 19.07.2024 while submitting the summary of HT, LT and Other works capitalized during FY 2022-23, has submitted that the HT & LT works, and other works amounts to Rs. 816.80 Crore and Rs. 96.63 Crore respectively. However, as per audited financial statements of UPCL for FY 2022-23 the amount of HT & LT works, and other works capitalized in FY 2022-23 is Rs. 852.19 Crore and Rs. 61.24 Crore respectively. UPCL is required to submit the reasons/justification for the same.
- 4. Division-wise expenditure (in Rs.) incurred under the head "देवीय आपदा"/force majeure condition for FY 2023-24 and FY 2024-25 (till December, 2024).
- 5. During the TVS held on 28.01.2025, it was pointed out to the Petitioner that the power purchase plan as submitted in the Petition for the upcoming Control Period does not coincides with the power purchase plan earlier submitted by UPCL through its Consultant M/s Mercados. In this regard, UPCL is required to submit justification/information for variance in power projections, for the same period, through two different submissions before the Commission.
