ORDER

Heard the Petitioner and Respondent in the matter on merits.

The Respondent is directed to provide a copy of its submission dated 06.10.2025 to the Petitioner within 7 working days.

During the hearing, the Commission directed the Petitioner to submit following information latest by **28.10.2025:-**

- (1) Submit its rejoinder on the Respondent's submission dated 06.10.2025, if any.
- (2) Year-wise shortfall in energy charges and corresponding generation since FY 2018-19 for the Dhakrani HEP and Khatima HEP.

- (3) Justification for claiming the recovery of entire shortfall in energy charges against 15.44 MU from UPCL in its Petition without considering the share of HPSEB Ltd. for Dhakrani HEP.
- (4) Details of bifurcation of generation losses due to Planned Outages alongwith reasons/cause thereof and RMU separately in the monthly generation loss sheet of Dhakrani HEP in hard and soft copy (excel sheet).
- (5) Details of unit-wise scheduled RMU period vis-a-vis as executed and unit-wise generation losses estimated in the DPR of RMU works of Dhakrani HEP.
- (6) Confirm under affidavit that no duplicity in generation loss exists amongst the various reasons/events claimed against generation loss for FY 2022-23 as submitted in reply dated 12.08.2025 for Dhakrani HEP and Khatima HEP.
- (7) The justification of reasons/events of generation loss claimed in the instant Petition for Dhakrani HEP and Khatima HEP vis-a-vis force majeure events mentioned at Clause 14 of the PPA dated 23.12.2017 and UERC (MYT) Regulations, 2021.

Ordered accordingly.
