ORDER

Heard the Petitioner on the issue of admissibility of the Petition.

During the hearing, the Petitioner was asked to clarify the nature of the present petition in relation to the Commission’s Order dated 02.09.2024. Additionally, the Petitioner was requested to explain the rationale for adjusting fees from a previously approved investment in the same matter, and the current status of the project was also inquired about.

The Petitioner informed the Commission that the present petition is a fresh filing and stated that PTCUL is in the process of finalizing the land acquisition with the assistance of the District Administration. The Petitioner further sought an additional two weeks’ time to make supplementary submissions to address the issues raised during the hearing, including the following:

- i. To clarify under what capacity/status of the Petitioner, the petition has been filed, whether as a State Transmission Utility (STU) or a Transmission Licensee particularly in view of paragraph 4.2 of the petition;
- ii. The Petitioner's submissions regarding the Commission's Order dated 02.09.2024 issued in connection with the same project, in light of paragraph 6 of the petition;
- iii. The status of the Detailed Project Report (DPR) as approved in the 89th meeting of the Board of Directors (BoD) of PTCUL, and a detailed extract of the 92nd BoD meeting concerning the present project.

Accordingly, the Petitioner is directed to deposit the applicable full fees, as required for any fresh petition, and to file the aforesaid supplementary submissions, alongwith all supporting documents under affidavit, with the Commission by 28.10.2025.

Ordered accordingly.
