The queries raised by the Commission and the replies submitted by PTCUL were discussed in detail as follows:

#### **A. True up for FY 2024-25**

1. It was observed that SLDC, in Form-6.1(B), has submitted the scheme-wise break-up of capitalisation amounting to Rs. 3.59 Crore for FY 2024-25, whereas in the Fixed Asset details of the Audited Balance Sheet, an amount of Rs. 5.71 Lakh has been booked under "Other Works." In this regard, SLDC has agreed to provide the details of "Other Works," including scheme-wise and item-wise break-up, nature of expenditure, and clarification regarding whether this amount pertains to adjustment of stock issues.
2. It was observed that SLDC in its reply dated 29.12.2025 has submitted the revised formats with respect to present Petition. In this regard SLDC has agreed to verify and clarify the date of completion and date of start of work in form 6.1 as follows:

3. It was observed that SLDC has capitalised the work i.e. "Construction of SLDC at Rishikesh and 2 Nos. Sub-SLDCs at Kashipur and Dehradun along with associated communication network," amounting to Rs. 37.40 Lakh. While SLDC has submitted the corresponding vouchers in support of the capitalised work, the Letter of Award (LoA) has not been submitted. In this regard, SLDC has agreed to submit the LoA against the aforesaid capitalised work.

#### **B. APR for FY 2025-26**

4. It was observed that SLDC, in its reply dated 29.12.2025 with respect to Query No. 11, has submitted expenditure amounting to Rs. 3.40 Lakh towards "Integration of existing NOC portal with NOAR portal." However, only internal notes and order have been submitted in support of the aforesaid work. In this regard, SLDC has agreed to submit the Work Order against the executed work.

### **C. ARR for FY 2026-27**

5. It was observed that SLDC, in its reply dated 29.12.2025 with respect to Query No. 16, has submitted the details of physical and financial progress for FY 2026-27. However, the works mentioned at Sl. No. 5 and 7, amounting to Rs. 16.72 Crore, appear to be within the scope of PTCUL. In this regard, SLDC has agreed to clarify the reasons for claiming the aforesaid works under its capitalisation.

6. It was observed that SLDC, in its reply dated 29.12.2025 with respect to Query No. 16, has reported NIL progress against most of the works proposed to be capitalised in FY 2026-27. In this regard, SLDC has agreed to re-assess the likely dates of completion by correlating the actual physical progress with the corresponding financial progress and to submit the revised capitalisation dates for such schemes.
