1. The Petitioner was required to resubmit the generation formats (after editing links of externally linked files) alongwith PDF format of the same.

The Petitioner in its reply submitted vide e-mail dated 23.02.2026 has mentioned that the same is being enclosed with the reply, however, the said information is still missing. The Petitioner is required to submit the same.

2. The Petitioner was required to submit soft copy of the books of accounts of all the ledgers comprising of total O&M expense claimed for FY 2024-25, i.e. R&M, Employee and A&G, including narration of each entry as recorded in accounting system.

The Petitioner in its reply vide e-mail dated 23.02.2026 has submitted only partial information. The Petitioner is required to submit the information strictly in line with the queries raised by the Commission.

3. The Commission vide its letter dated 05.02.2026 directed the Petitioner to submit its reply on the additional reply/information sought by UPCL w.r.t the ARR Petition filed by M/s GIPL for FY 2026-27.

In this regard, the Petitioner has not submitted the requisite information till date. The Petitioner is required to comply with the direction of the Commission.
