Subject:- Extension/ provisional affiliation of one year to Private Schools for academic session 2020-2021.

Please refer to the subject cited above.

That keeping in view various representations received from the Private schools Associations for the extension of provisional/temporary affiliation and in the interest of students studying in such schools, State Government had set up a committee under the chairmanship of Director Secondary Education, Director Elementary Education, State Project Director (SPD), Haryana School Shiksha Priyojna Prishad (HSSPP) and representative of Advocate General, Haryana.

The committee considered all the statutory provisions regarding granting recognition to existing/temporarily recognized/unrecognized Private Schools and suggested comprehensive simplified norms so that the ambiguity in recognition rules could be removed. The amendment in the rules on the basis of committee report is under consideration at Govt. Level. In these circumstances, the State Government has decided to grant provisional affiliation to the aforesaid schools, the cases of recognition of which have not been finalized by the Department/District Level Committees, for another academic session i.e. 2020-21 with the condition that:-

- (i) Firstly, aforesaid schools shall have to produce the proof of temporary recognition/affiliation granted by the department during the last session i.e. 2019-20.
- (ii) Secondly, no further extension will be granted to such school from the next academic session i.e. 2021-2022.
- (iii) Thirdly, any act contrary to the provisions of the rules will invite appropriate action under the relevant rules.
