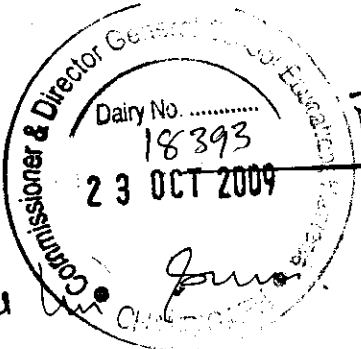

The petitioner had challenged the appointment of respondent No.5, who was appointed as Guest teacher. Now regular appointment has been made and accordingly respondent No.5 has been relieved.
